NARCISISTIC SELF- ESTEEM

PROTECT US FROM OURSELVES

A recently published article reveals that some educators are now beginning to see what HR professionals have recognized for several years. It seems that "empty praise" and meaningless accolades may not actually produce an intelligent human being after all

For probably the better part of two decades the education mindset in this nation has been largely based on Esteem building techniques, with much less emphasis placed on accuracy than on feelings and self-worth of the individual student. They didn't necessarily have to be right, but they absolutely had to feel good about themselves in the process.

This evolved into a world where there were no losers, everybody was a winner, and trophies and ribbons went to everyone – just for being there.



If they could just get real life to cooperate with that philosophy, everything would have been ok.

According to the article, "A growing body of research over three decades shows that easy, unearned praise does not help students but instead interferes with significant learning opportunities."

In fact, researchers are now finding that empty praise – esteem building without a proper foundation of achievement, can have the direct opposite effect from what was intended. They have found, in "study after

study", that "children rewarded for being smart become more likely to shy away from hard assignments that might tarnish their star reputations." This is very, very bad news for the companies that print those "My Child Was Student of the Week" bumper stickers.

None of this will be a shock to some human resources professionals, who are now attempting to figure out what makes the Gen Y generation tick. In fact, employers have been struggling in recent years with the first full wave of these new workers, fresh from their idealistic upbringing and outcome based education, where failure was not an option only because there was no such thing as failure.

There have been warning signs. In 2007 a study showed that college students were far more narcissistic than their 1980's predecessors. In fact, of the 16,475 students who completed the "Narcissistic Personality Inventory", fully two thirds had above average scores, an increase of 30% over 1982.

These students were described by the researchers as "self-centered", and were "more likely to have romantic relationships that are short-lived". Additionally, they were "at risk for infidelity, lack emotional warmth," and more likely to "exhibit game-playing, dishonesty, and over-controlling and violent behaviors." Not the stuff of heroes, to be sure.

So, we can be encouraged that some educators are finally figuring it out, and modifying their approach.

Our parents were right. Actually learning something and learning it correctly may be the best thing for a person's self-esteem.

I can hardly wait for the first batch of students taught that way to emerge. Prepared, intelligent, unburdened by the weight of 2,000 meaningless ribbons, they will confidently enter the workforce and selflessly fund the social security system. God Bless them. There is hope.

Failure to comply with the following list will result in termination of your iPhone ownership.

I love you madly and look forward to sharing several million text messages with you in the days to come.

- 1. It is my phone. I bought it. I pay for it. I am loaning it to you. Aren't I the greatest?
- 2. I will always know the password.
- 3. If it rings, answer it. It is a phone. Say hello, use your manners. Do not ever ignore a phone call if the screen reads "Mom" or "Dad". Not ever.
- 4. Hand the phone to one of your parents promptly at 7:30pm every school night and every weekend night at 9:00pm. It will be shut off for the night and turned on again at 7:30am. If you would not make a call to someone's land line, wherein their parents may answer first, then do not call or text. Listen to those instincts and respect other families like we would like to be respected.
- 5. It does not go to school with you. Have a conversation with the people you text in person. It's a life skill. *Half days, field trips and after school activities will require special consideration.

m he}$ Daughters of the American Revolution, one of

the nation's oldest patriotic organizations, has erased any mention of Jesus Christ in their official book, removed prayers and poems that reference Christian imagery, and directed members to refrain from praying in the name of Christ, an outraged group of members alleged.

The dispute has been brewing for more than a year when DAR members learned that the newly revised Ritual and Missal books - the primary guide for chaplains – were altered. They noticed that the name of Jesus Christ had been omitted.

The DAR president general did not return calls seeking comment for this story.

The members said DAR leadership made the changes to be politically correct and to accommodate new members of other religious beliefs.

A state chaplain in the organization notified members of their concerns in a newsletter.

"The newly updated Missal and Ritual was written to reflect the desire to be considerate of other belief systems," the statement read. "The Chaplain General uses scripture from both the Old and New Testaments and prays in the name of God without reference Christ. Chapter and district chaplains need to follow the example set by the National Society." The statement also reminded members to "appreciate the differences in members' religious beliefs and to adapt our rituals and prayers to respect these differences."



That directive has infuriated rank and file members of the DAR – an organization that is deeply rooted in the Christian faith.

Several members of the DAR spoke with Fox News about their concerns – on the condition they remain anonymous.

"They are changing the legacy and intent of the Founding Ladies and rewriting the history of the Daughters of the American Revolution," one member told Fox News. "How dare they? They're supposed to be doing it out of inclusion. To me, it's exclusion. If they are saying it's because of religious tolerance - my question is - if someone is so incensed over the name of Jesus and words like 'white crosses' that reference soldiers who died for America - is it not they who are intolerant?"

The DAR has also reportedly eliminated an oath to the Constitution, a promise to respect the American flag, as well as patriotic hymns that reference God - including "America the Beautiful." Members were told those items were inadvertently left

out of the revision and will be included in future publications.

"A group of us went through the Ritual and Missal and compared the old version and the new version," another member told Fox News. "Every single prayer closing in the name of Jesus Christ no longer included the name of Jesus Christ."

"For 122 years Christianity was included in the Daughters of the American Revolution," said one member. "Without the name of Jesus Christ it is surely not Christianity. This has never been an issue until December of 2011."

The DAR was founded in 1890 as a non-profit, non-political volunteer women's service organization. Membership is open to any woman who can prove they are a lineal descendant of a patriot from the American Revolution. The organization has 170,000 members in 3.000 members.

The members said they tried to bring their concerns to the organization's leadership but were rebuffed.

'The response from the leadership was one of being inclusive and being sensitive to non-Christians and other beliefs." a member said. "The minority rules instead of the majority."

One chaplain said it broke her heart to take Jesus out of the prayers and there are reports that some members have resigned.

The members said they were particularly disturbed that the changes were made without the vote or the approval of the 170,000 membership.

And many are perplexed over who might be so offended by the mere mention of the name of Christ. "Who is it that is so incensed over the name of Jesus and any Christian symbol or reference – that they feel like they have to eliminate it from the Daughters of the American Revolution." one member asked.

They said Christianity had never been forced on any members but to remove it from the historic organization's documents is a "deception and twisting of history."

"They are negating our history, changing our history," one lady told Fox News. "This country was blessed by God Himself. Most of our Founding Fathers had Bibles in their hands and Jesus in their hearts and therefore America became what America is today. And through the last decade, it's been a constant chiseling away of our Christian foundation - our Judeo-Christian foundation."

Living Wax Museum Info

Activity: Students will select a historical person to research They should write a paragraph that includes the answers to the following questions:

- 1. What is your full, original name?
- 2. When and where were you born?
- 3. What were some interesting things that happened to you?
- 4. Why did you become famous?

Students should select an appropriate costume that their character might have worn during their lifetime. Parents are responsible for providing their children with an appropriate costume, make-up, props, etc.



Each figure will come up with a clever way to begin their presentation (to make their character "come alive"). As visitors mill about the museum, they will stop at the various figures scattered throughout the room and follow the directions posted by the child (parents) to bring the character alive.

For example, if a participant is a queen, they might post instructions telling quests to curtsey or bow. When a quest curtseys or bows the character will "come alive" and recite the paragraph that they wrote. Once they have finished, they will strike a pose and "freeze" until a new quest comes along and begins the process over again. (Understandably, some students will be able to "freeze", while others will be fidgety due to age constraints.)

INVITE grandparents, friends, etc. to visit our wax museum. The more guests we have the more fun it will be for the students. We have scheduled the event on a Saturday evening so dads, grandparents and friends can come.

Is Vanderbilt University waging a war on religion?

 ${\mathcal M}$ any of the university's religious student groups think so. They have been told by the administration that they cannot have faith or belief-based requirements for leadership. That means an atheist could run for leadership of a Christian group, a Jew for leadership of a Muslim group, a Pagan for leadership of a Catholic group, and on and on.

It's all written into Vanderbilt's nondiscrimination or "all-comers" policy. All student groups must register next month. As part of the registration, they must sign a statement of affirmation that they will abide by the nondiscrimination policy.

Vandy Catholic -- a student group with some 500 members -- has decided it cannot agree to the policy and will be leaving campus in the fall. PJ Jedlovec, the president of Vandy Catholic, says it was a difficult decision, one made after much prayer and discussion.

"We are first and foremost a Catholic organization," says Jedlovec. "We do, in fact, have qualifications – faith-based qualifications for leadership. We require that our leaders be practicing Catholics. And the university's nondiscrimination policy -- they have made it clear that there is no room in it for an organization that has these faith-based qualifications."

The university says it is "deeply disappointed" by Vandy Catholic's decision. But the administration is sticking by its guns. In a statement provided to Fox News, Vice Chancellor of Public Affairs Beth Fortune said, "We do not believe our nondiscrimination policy to be incompatible with religious freedom. Vanderbilt's policy does not mandate whom student organizations should elect as leaders -- it simply allows for anyone to be

eligible for membership and to seek a leadership position."

Religious groups used to have an exemption from the university's nondiscrimination policy, but that language was erased last year. The Christian Legal Society, which was cited as being out of compliance with the nondiscrimination rules, points out that fraternities and sororities are exempt from the "all-comers" policy and that religious groups should be, too.

What's ironic is that Vandy Catholic is in compliance. It's constitution simply states that potential leaders must be "undergraduate students at Vanderbilt University." But when the school reiterated its policy in preparation for spring registration, Vandy Catholic leaders felt their hands were tied.

Father John Sims Baker is Vandy Catholic's chaplain. He told Fox News, "I was trying to withhold judgment about it. But I do have to say I really felt kind of kicked in the gut – actually...that's what I felt. I thought, you know, I could sort of see where I was afraid this was going."

As a private university, Vanderbilt is allowed to make rules that might not pass muster at a public institution. In fact, Tennessee lawmakers are working on legislation that would specifically prohibit state universities from extending nondiscrimination policies to student religious groups.

In another attempt to change the school administration's mind, other religious groups on campus plan to sign the statement of affirmation, then submit charters that clearly outline a faithbased criteria for leadership.

That will likely provoke another confrontation with Vanderbilt leadership -- one that may see more religious student groups leave.

State Sued over "Year Of The Bible"

 ${\cal H}$ ARRISBURG, Pa. – A national atheist and agnostic

group is suing Pennsylvania lawmakers for passing a resolution that declares 2012 as "The Year of the Bible."

MyFOXphilly reports the Freedom From Religion Foundation (FFRF) filed a federal lawsuit arguing that the Pennsylvania House's declaration is unconstitutional.

The resolution, which was authored by State Rep. Rick Saccone, passed unanimously in January 2012.

The lawsuit names Saccone as one of three plaintiffs, and claims the resolution is tantamount to the state endorsing "state-sponsored religion."

They also claim to take issue with content in the Bible, including "violent, sexist and racist models of behavior that FFRF members find personally repugnant."

"(This content) potentially could encourage persons who rely on them to act in a manner harmful to them and others," the lawsuit claims.

Saccone has said the resolution is meant to recognize the impact the Bible has had on the U.S. and on the state, and does not inhibit anyone from believing or not believing in any faith.

"Most citizens don't remember that a joint session of Congress passed a similar resolution signed by President Ronald Reagan on February 3, 1983, declaring that year as the Year of the Bible in America," Saccone said.

Democratic Rep. Mark Cohen said he wanted to reconsider the resolution, and that he regretted that he didn't realize the resolution's content at the time of the vote.

Gay Porn Actor Reinstated As Teacher

State University of New York at Stony Brook has decided to no longer cancel classes for major Christian and Jewish holidays

in an effort to ensure that some religions are not given special treatment and to "afford equal support and equal respect to students and faculty from all faiths."

Jewish students would be impacted on Rosh Hashanah, Yom Kippur, Passover and Holy Week.

Christian students would be impacted on Good Friday. The Christmas holiday is protected under a union contract and occurs when classes are traditionally not in session.

The university had considered allowing faculty to schedule exams on Saturday and Sunday — a time when many Christian and Jewish students attend worship services. However, that decision was tabled after reaching a compromise with students.

"As a secular university, as a state-funded university our priority must be to maximize instructional opportunities for our students," said Charles Robbins, vice provost for undergraduate education. "First and foremost, it's important to note that while I respect everyone's concerns, the reality is it's a relatively small number of people who are upset."

Robbins told FOX News Radio the university's decision to stop canceling classes for Christian and Jewish holidays offers "equal protection under the regulations to everybody and no one is getting quote, unquote, special treatment."

No statement was issued regarding Islamic holy days or holidays of religions other than Christianity and Judaism.

A former gay porn actor and director who was fired for violating the Miami-Dade School Board's code of ethics has reportedly been cleared to pursue his teaching certificate again.

Shawn Loftis, 36, spent six years in gay pornography and owned his own company, *World of Men*, until he quit the industry in 2010. He then got a job as a substitute teacher at Nautilus Middle School

in Miami Beach, but was later targeted in a "moral crusade" by the school's principal and was eventually fired for violating the Miami-Dade School Board's code of ethics and for gross immorality, NBCMiami.com reports.

In November, the Florida Department of Education banned Loftis from obtaining a teaching certificate for five years, but that decision was reversed by the state's Education Practices Commission, the website reports. And since he has already passed the exam, Loftis just needs a job to resume teaching.

"I just hope that a position comes available at **Miami Beach High**; **that is where I really want to be**," he told the station.

Miami-Dade Public Schools spokesman John Schuster said the certificate, however, does not guarantee employment.

Modesto California teacher leaves wife, children to live with one of his students

Controversy is continuing to swirl around a 41-year-old Modesto teacher, who resigned his position, left his wife and moved in with an 18-year-old student; a girl who is only 1 grade older than his own daughter.

The former Enochs High School teacher, James Hooker, is fighting back against allegations that he did something illegal as police investigate whether the relationship began before the girl turned 18.

Jordan Powers' mother said she has proof their relationship began sooner. She said she has text messages, phone records and a police report to help build her case.

Hooker has left his wife and children, including a daughter who is a junior at the same high school.

"There would be nothing to arrest me on," Hooker said. "There was no relationship before she was 18. There's a lot of rumors going on."

He also called his girlfriend's mother's allegations a "pack of lies" and urged people to be careful in choosing what to believe.

Modesto City Schools Supt. Pam Able confirmed Hooker's resignation. In an email to the Modesto Bee, Able confirmed Hooker's resignation and said that

allegations of the relationship are a "source of great concern for staff, students and parents."

"I consider student-teacher dating relationships to be not only unprofessional,but immoral," Able said.

The couple appeared on "Good Morning America" and "Dr. Phil" to defend their relationship.

"I don't regret anything," Hooker said.

"He's my best friend," 18-year old
Jordan Powers said. "I mean, he's more than just a lover."

However, since then, another former student has come forward to say that she had a sexual relationship with James Hooker when she was a 17 year old student at Modesto's Beyer High School and Hooker worked at Modesto's David High School.

Modesto Police Department has arrested James Hooker charging him with one count of sexually assaulting a teenage girl for the incident that police say happened 14 years ago. The case is pending.

State Subsidized Child Care

Illinois - Cornelius Osborne may not seem like babysitting material. He was convicted of raping two women. A succession of felonies, from robbery to failing to register as a sex offender, repeatedly sent him to prison, state records show.

But over more than two years, the state paid Osborne nearly \$5,000 to baby-sit two children, before his latest conviction for dealing drugs put him back behind bars.

Osborne wasn't the only sex offender paid by taxpayers to baby-sit. An investigation found cases of convicted rapists, molesters and other violent felons given access to children over the past decade.

The money comes from a \$750 million-a-year program that subsidizes child care for more than 150,000 impoverished Illinois families.

 ${\mathcal A}$ 'cool' California high school teacher was taken into custody after she allegedly helped her students get high, <u>FoxNews reported</u>.

Japhia Huhndorf, a chemistry teacher at Livingston High School in Sacramento, allegedly ordered chloroform through the school but did not use the ingredient in her lessons.

Police allege that Huhndorf took three students, ages 16 to 18, and 'either showed them how to do it or she poured it on a cloth for them to inhale,' the station reported, citing Ray Fong, a police sergeant.

She didn't encourage the students to get high, a teenage victim told the station. It was "just to ease the stress."

One student apparently passed out after using chloroform with the teacher.

The alleged abuse spanned two months during what should have been after-school tutoring sessions.

 \mathcal{M} iramonte Elementary School was closed for two days to allow the Los Angeles Unified School District (LAUSD) to replace the entire staff.

Relocated employees include administrators, teachers, secretaries and custodians. The displaced staff will continue to receive pay and will undergo counseling.

The decision comes after the arrest of two Miramonte Elementary teachers for alledged lewd acts against students.

Both men accused of committing sex crimes against children are in custody.

Mark Berndt, was arrested and charged with committing lewd acts involving 23 boys and girls at the school.

Martin Bernard Springer, was arrested and booked on suspicion of committing lewd acts upon two 7-year-old girls at the school.

 ${\mathcal A}$ man arrested after allegedly making comments on an ESPN website about **killing children** has been identified as a resident of **Valencia CA**.

The suspect is 21-year-old Eric Yee. He is accused of posting comments at a sports-focused ESPN blog or chat room in which he allegedly said he was "watching kids and did not mind murdering them," according to a press release from the department's Santa Clarita Valley Station.

"The blogger mentioned that it would be like the Aurora, Colorado shooting," the press release said.

Bristol, Conn-based ESPN alerted police to the online post. Bristol police then traced the post to Yee.

"The Internet service providers at one of the ESPN sites were very good and acted diligently in contacting police," Los Angeles County Sheriff's Department Sgt. Darren Harris said.

Several firearms were found inside Yee's home in the 23000 block of Edenton Place, Valencia. The residence overlooks **Santa Clarita Elementary School and Arroyo Seco Junior High**. Parents with children at the schools said they were briefed on emergency response procedures.

A search warrant was served on the home after detectives conducted surveillance of the location, the Sheriff's Department said.

Neighbors said the suspect lived in the home with his parents and was "well educated."

The Sheriff's Department said it was in contact with Yale University police "to ascertain if there are any outstanding suspects." It was not clear what

Monday, December 14, revealed every parent's nightmare. Adam Lanza murdered six adults and 20 children at the Sandy Hook Elementary School in Newtown, Connecticut, in addition to his mother, whom he murdered at their home.

The massacre has ignited the debate over gun control, coming at the end of a year in which several major mass shootings took place, before and after the school killings, at which most of the victims were six or seven years old.

The U.S. Supreme Court will not intervene in a controversy over Christian prayers delivered before commission meetings in Forsyth County, North Carolina.

The North Carolina chapter of the American Civil Liberties Union and Americans United for Separation of Church and State praised the decision as a victory for the First Amendment.

The high court's decision leaves in place a federal appeals court ruling that held that the predominantly **Christian prayers at the start of commission meetings violated the First**

Amendment's alleged ban on government endorsement of a particular religion.

The court found that more than three-quarters of the 33 invocations given before meetings between May 2007 and December 2008 referred to "Jesus," "Jesus Christ," "Christ," or "Savior."

That, according to the court was a problem.

"Faith is as deeply important as it is deeply
personal," Judge J. Harvey Wilkinson wrote in the July
29th appellate court ruling. "and the government should
not appear to suggest that some faiths have it wrong and
others got it right."

COURT RULES AGAINST PRAYER IN "IN JESUS' NAME"

 ${\it F}$ or the past seven years Pastor

Terry Sartain has ministered to police officers and their families in Charlotte, N.C. Whenever the Charlotte-Mecklenburg Police Dept. invited him to deliver an invocation, he prayed in "the name of Jesus."

Volunteer chaplains in the Charlotte-Mecklenburg Police Dept. will no longer be allowed to invoke the name of Jesus in prayers at public events held on government property.

Major John Diggs, who oversees the chaplain program, told **television station WSOC** that the policy is a "matter of respecting that people may have different faiths and that it is not aimed at any one religion or denomination."

Sartain, the pastor of Horizon Christian Fellowship, told Fox News Radio he was scheduled to give an invocation at a promotion ceremony. Before the event, he received a telephone call from his superior major.

"I was told chaplains can no longer invoke the name of Jesus on government property," Sartain said. "(He said) if I could refrain from that during the invocation he would appreciate that."

Sartain said he was surprised by the telephone call. The pastor said he's prayed "consistently" in the name of Jesus at past police department events without any issues.

"I'm very sad about it," he said. "I'm a pastor and Jesus is the only thing I have to offer to bless people – his life and his person."

"It brings about a very real concern about where we are heading as a nation," he said. "I serve a God who loves people unconditionally, who died for their sins on the cross, who wants to reconcile himself to them and love them where they are at – and now I'm told I can't bless people as a result of that."

The police department said he could still pray – just not to Jesus. So to whom was the

Christian minister supposed to pray?

"That was my question," Sartain said. "If I'm going to pray – what should I pray?"

He said the police department wanted him to deliver a "secular prayer."

"Even when I wasn't a Christian – in my past – I didn't even know what a secular prayer was," he said. "Why even pray if it's to the one who's in the room? That could be anybody."

Sartain said the new policy has put him in a difficult spot.

"You don't want to compromise your faith," he said. 'At the same time you want to honor those who are in charge over you."

So Sartain asked the police department to withdraw his name from consideration for future public prayers.

"I didn't really need to do that as a chaplain," he said of the public prayers. "I still wanted to have the influence with the police officers and their families."

At least some people in the Charlotte area support the decision to remove the "Jesuscentric" prayers.

"It's past time when they should've made a policy," ACLU member Jim Gronquist told WSOC. "It's improper to mix up religion with the function of state agents, and as long as they're state agents, they should not be able to do that."

Sartain said it's apparent that "Christians for the most part are targeted in these days that we exist in."

"As Christians in the United States of America – what we are saying as believers – is we want the same rights and privileges as everybody else," he said. "Let the playing field remain level."

Executive Director Barry Lynn
hailed the Supreme Court's
decision not to consider the case.
His organization was one of the
groups sponsoring the lawsuit.

"When government meetings are opened regularly with Christian prayer, it sends the unmistakable message that non-Christians are second-class citizens in their own community," Lynn said in a statement. "That's unconstitutional, and it's just plain wrong."

But David Cortman, an attorney representing Forsyth County, said the ruling makes **Christians second-class citizens**.

"That's what this case shows," said Cortman, an attorney with the Alliance Defense Fund. "We believe the Supreme Court has missed an opportunity to clear up the differing opinions among the various circuit courts. It really is disappointing."

The decision means prayers are still allowed, but the county must police the words to make sure one faith group is not represented over another faith group.

"America's founders never shied away from referencing the God to whom they were praying when offering public invocations; the citizens of Forsyth County should have this same opportunity," Cortman wrote in a statement. "No federal court has ruled that prayers cannot be offered before public meetings."
