As such, ZiDiKiSM holds no responsibility or association with any claims that may arise against or from any given business or affiliate.
- 3. ZiDiKiSM offers the following type of membership: Fit, fitplus, Superfit, Xtremefit, and Pay-as-you-go. Details of these types of membership are set out on the Membership (Join Now) page in our website form and may be changed from time to time at the company's discretion. Opportunities to upgrade or downgrade are available at any time.
- 4. This agreement was duly and fully completed by electronic signature by the Member, and the information contained herein is true and correct. ZiDiKiSM reserves the right to cancel the agreement if the information supplied is found to be incorrect and/or false.
- This agreement contains all the terms of conditions of this agreement any addition, variation or cancellation of this agreement, including this paragraph, shall not be of any force and effect unless reduced writing and electronically signed by all parties.
- The Member confirms that the company has the right to decline his or her application, in its sole and absolute discretion and without having to give any reasons therefore.

- 2. Member understands that the agreement to use, selection of exercise programs, methods, routines, and types of equipment or locations shall be the member's entire responsibility and ZiDiKiSM. As such the Member acknowledge that the company, its directors, employees, agents consultants, affiliates, network participants, contractors or representatives or the owner of the building shall not be responsible nor liable for any injury or loss suffered by the Member and/or any of his or her family members or guests, anyone on member's behalf, whether or not through any negligence and/or omission on the part of the company, its employees, agents, consultants, contractors or representatives of the company or the owner of the building for any reason whatsoever and howsoever arising.
- 3. In the event of the Member signing this contract as the guarding of any minors the Member hereby consent to such a minor being bound by the terms of this agreement, and the Member hereby indemnify the Company, its directors, employees, agents, consultants, contractors

and representatives and the owner of the building against all claims that may be made against them for or on behalf of such minors. As such, the Member undertakes to use the location facilities and equipment entirely at his/her own risk.

4. The company and the owner of the building will not be responsible for any loss, theft or damage to personal property of the Member, his or her dependants, guests or any third party/ies and as such the Member hereby waive any rights to sue the Company and/or the owner of the building for lost or stolen articles. The Member hereby indemnify the company, its directors, employees, agents, consultants, contractors, and representatives and the owner of the building and then hold them harmless against any and all claims arising out of any damage to the property of third party/ies, caused by the Member, his or her dependants, guests or third party/ies, whether caused intentionally or accidentally.

Payment Terms and Conditions

- 1. If payment is by means of monthly debit order, the membership period will commence on the date which the company opens or the date of acceptance as a member, whichever is the later date and will continue for consecutive months as set out in this agreement; this is considered "the Initial Period". - No refunds will be provided for any current fees or prorated payments. Payment cancellation will take effect for next billing cycle and future payments will be cancelled.

Business or Network Participant Terms and Conditions

Breach of Agreement
