- Presentations can be case studies of design or construction projects or can also feature techniques, processes, or technology in line with the event theme.
- Presentations should ideally feature companies and content which are local to the hosting province/city.
- Presentations **MUST** be cleared for public use, as they will be recorded and made available through the CanBIM YouTube channel and other online platforms.
- The length of presentations should be no more than 30 mins.
