


WHAT IS SHARIA?

Islamic Law, the 'divine law', is derived from the teachings and example of Mohammed as set out in the Koran, the biography and reported sayings of Mohammed (the Sira and Hadiths). It is codified in manuals, especially 'The Reliance of the Traveller' compiled in the 14th Century.

Sharia deals with crime, politics, and economics, and lots of personal matters such as sexual intercourse, hygiene, diet, prayer, everyday etiquette and fasting.

Interpretations of sharia vary between cultures, but in its strictest definition it is considered the infallible law of God.

Sharia regards human law-making (as in Western democracy) as BLASPHEMY.

Only under sharia law can Muslims practise pure Islam, so its introduction into kafir society is the cornerstone for Islam to overthrow the kafir world, including Australian society.


Under Sharia Law there is:

Sharia Law and Female Genital Mutilation (FGM) must never be allowed in Australia!

The WHO identifies 4 types of FGM:

Type 1: Removal of the clitoral hood, the skin

around the clitoris (1a), with partial or complete removal of the clitoris.

Type 2: removal of the labia minora (2a), with partial or complete removal of the clitoris and the labia majora (2c).

Type 3: removal of all or part of the labia minora (3a) and labia majora (3b), and the stitching of a seal across the vagina, leaving a small opening for the passage of urine and menstrual blood (infibulation).

Type 4: other miscellaneous acts, including cauterisation of the clitoris, cutting of the vagina (gishiri cutting), and introducing corrosive substances into the vagina to tighten it.

Sunna Circumcision (Type1):

The tip of a woman's clitoris is shaved or cut off.

The word "sunna" refers to Muhammed's early tradition of the practice. This form of FGM can be found in many countries in both East and West Africa, and other countries in the Middle East.

FGM is a crime against humanity and its time that a united voice across the world was raised to condemn this barbaric practice!

The sad and disgusting issue of under age Sexual Relations

Do we want Sharia Law to creep into our society? If your answer is “no”, well what are you doing about it, as countries such as France didn't recognise the creep and now its too late.

Sharia is an Islamic Law which deals with several topics including: crime, politics and economics as well as personal matters such as, sexual intercourse, hygiene, diet, prayer everyday etiquette and fasting. Sharia Law is based on the teachings and example of Mohammed as articulated in the Koran and his biographies, Sira and Hadith.

To be a Muslim is to believe that Mohammed is the perfect man. Mohammed was such a 'perfect' man that he consummated his marriage to Aisha when she was 9 years old. He was such a good man that he reluctantly allowed the poor girl to bring her dolls to his harem. That was big of him wasn't it?

A disturbing aspect of Sharia Law is its following of the example of Mohammed with the minimum age for marriage being nine years old and once married a girl has no rights in refusing to sexual intercourse with her husband, except under extreme circumstances.

The leader of the Iranian Revolution in 1989 Ayatollah Ruhollah Khomeini wrote extensively on Islamic Jurisprudence.

“A man can have sexual pleasure from a child as young as a baby, however he should not penetrate. If he penetrates and the child is harmed, then he should be responsible for her subsistence all her life. This girl however would not count as one of his four permanent wives. The man will not be eligible to marry the girl's sister” (Ayatollah Khomeini, as cited in Tahrirolvasyleh, Fourth Edition, Darol Elm, Qom)

How disgraceful are the actions of this noted Islamic leader when you read the account *by the late Sheikh Abu Mus'abaz-Zarqaawi on Ayatollah Khomeini's rape of a small 4-year old child.*

“Imam al-Khomeini spent the night with the girl in his arms, and we could hear her crying and screaming [through the night].”

More recently, British Muslim social and political activist Imam Choudary claimed that 9 year old girls are mature enough to be having sex and stated his view of "we believe that the lower age for the woman to become mature, meaning she is a mature woman iat the age of nine and there is nothing wrong with that"





Opposed to sharia in Australia?

Too late: it's already here!

Sharia law is the Muslim political/legal system or religious instructions covering every aspect of Muslim life from finance to sexuality; from laws to government. It covers the 5 pillars of Islam (prayer, diet, jihad etc), FGM, marriage age, dress (hijab), divorce laws, custody, inheritance, borrowing rights and much more.

Most religions have instructions on how one lives life, but the main difference between Islam and others, is that one Sharia ruling - apostasy - punishment for criticising Islam, Sharia or leaving Islam (blasphemy) ensures that no other aspect of Sharia can be criticised or ignored. It is this aspect of Sharia that makes it so unacceptable in Australia as no Muslim is permitted to reject it (even if they sought asylum here to escape it). And given the nature of Sharia, Australian law may well be superseded by Islamic law. For this reason a dual legal system is not right for Australia.

Sharia already operates wherever there are Muslims since it covers wedding rituals, prayer, funerals and diet (halal). In Australia, we also see cases of FGM (for which we are now prosecuting our first case) and child-marriage in which we see up to 130 cases a year.

Most Muslim groups in the west want a watered down version of Sharia. This is because punishments such as cutting off people's hands for theft have become unacceptable to the majority. The problem is, the versions they want installed are those which adversely affect women - such as divorce rights and custody. A woman has no say in the custody of her children, and she is in no position to ignore this ruling and seek secular legal assistance to get access because she would be seen as an apostate and cast out of her community. So she is stuck. Accept Sharia, and its unjust treatment of women and children's rights - or leave Islam and be subjected to (underground) punishment.

The Islamic Council of Australia has made a formal request for Sharia in Australia to operate alongside Australian law as a dual system. This is already the case in the UK where Sharia courts are not official, but are tolerated. It exists also, in some states of the US and Canada. Canada had some opposition from Islamic women's groups because of the oppression of women under Sharia, but Canada appears to have ignored those concerns under the guise of religious freedom; freedom to oppress.

In regard to Sharia law in Australia; in 2006 Peter Costello said 'there is one law that we are all expected to abide by (and) if you cannot accept that, then you don't accept the fundamentals of what Australia is and what it stands for'. Exactly! In a democracy we are all equal before the law. We understand this and are well acquainted with what is expected of all of us. Islamic law and culture has provided 'legal' loopholes for cases such as that of an Afghan-Australian who claimed a culture of rape, and an inability to understand that a woman is free to say 'no' in appealing his sentence. This appeal was granted in the name of multi-culturalism.

So, if Sharia is already operating, the question is, should our governments tolerate it? A government report has examined dual legal systems in the west and concluded that, although it might provide some transparency and go a long way to protecting women and children, it fails those who do not wish to live by Sharia; so they have suggested Australia is not ready for it. This situation is unlikely to change under this government.

Sharia law is Muhammad's law

Religion was law and Muhammad was the lawgiver. He fancied himself Moses coming down from the flashing mountain with the commands of the Lord inscribed on stone tablets, but he was Moses with a much broader mandate. Whereas the Jewish patriarch brought the commandments to his own people, Muhammad saw himself as messenger of the Lord to the entire world. His grandiose idea of himself expanded to the point he believed he was chosen to transmit the law even to the invisible jinn as a comprehensive set of rules that defined the narrow path leading to Paradise.

When he came down from the mountain, Muhammad was lugging a staggering pile of rules, regulations, prohibitions, and promises regarding sex. He came down with rules concerning who could marry whom; he imposed celibacy on the unmarried; he prescribed purification rituals following sex and forbade praying until they were carried out. He forced the segregation of the sexes, imposed the veil on women, and regulated the movement of women outside the home. For adultery he imposed the death penalty, and for sex outside of marriage, a severe flogging. Yet, as an incentive to get men to fight for him, he allowed them to take captive women as sex slaves, and he promised unending sex in Paradise to men who died fighting for his cause.

Prior to Muhammad's descent from the mount, the men and women of Arabia were not particularly self-conscious about nudity. Both stripped to the buff to orbit the temple of Mecca when they could not afford ritual clothing. Young women would sometimes sashay through village or town dressed only from the waist down with their long hair cascading over firm breasts. They decked themselves out with earrings, bangles, and ankle bracelets, and they wore saucy perfumes that trailed far behind them. Even Muhammad liked to ogle pretty women. But for him there was blowback when his harem grew to include a share of young beauties. His own people—believers in the oneness of Allah who feared the punishment of the fire—were taking to ogling his women! How could they not? Like rows of motel rooms, the doors of their abodes

opened on the mosque courtyard, and their comings and goings were there for all to see.

The veil was an innovation Muhammad came up with at the time he married Zaynab, his former adopted son's former wife as a way of shutting out these gawkers. The last straw came when several male guests lingered behind in Zaynab's room following the wedding feast, and Muhammad suspected the real reason was that they desired her as much as he did. Her looks intoxicated them. As with wine and liquor, he put an end to the intoxicant by requiring all believing women from then on to wear the veil. And not just a veil over their face, but also full body cover. Let the lust of no one be aroused by the curvature of those breasts and hips! God called down to Muhammad from the top of the mount: "O Prophet! Tell thy wives and thy daughters and the women of the believers to draw their cloaks close round them (when they go abroad). That will be better, so that they may be recognised and not annoyed. Allah is ever Forgiving, Merciful."

As with everything, Muhammad took it to an extreme. He defined who could see women without full body cover even when they were at home. Thus women were allowed to wear normal clothes in the presence of blood relatives and in-laws, but if anyone else came to the home they had to stay behind a screen and speak if spoken to from behind it. They could only come out from behind the screen if they dressed up in full garb. All of Muhammad's wives came under this invisibility rule, including when he took them with him on raids. They were required to ride inside stuffy howdahs, curtains drawn. When encamped, they stayed behind a curtain inside Muhammad's tent to keep from the gaze of men who came in to consult with him about campaign matters.

Muhammad's overturning of old sexual mores was hard on men as well. Previously Arab males enjoyed a robust sexuality, the only complications being paternity. The story is told of a beautiful courtesan in Mecca who had a son who became a famous poet. Meccans by the dozens claimed paternity. Such matters were typically disposed of by tribal councils with a wink and a nod. Men and women indulged in temporary marriages, short-term contractual

arrangements that required a dowry, but at the end of the stipulated period, both parties walked. Sexual jealousy had to have been one of the complications of the freewheeling, but there is not any record of blood being spilt because of it. Under the new regime, men who were not married were now required to remain celibate, an inducement to marriage, but many did not have the means to pay for the dowry that was required for marriage. Thus they were eager to participate in raids in order to make money from booty, or even better, score themselves a sex slave. Any unmarried man or woman caught engaging in "illicit sex," as Muhammad branded sex outside of wedlock, suffered a penalty of one hundred lashes and banishment for a year. Adulterers were taken to an execution spot outside the main gate of the mosque and were stoned to death. Before their execution, they were made to suffer one hundred lashes.

The flogging itself was regulated. The punishment had to be inflicted with a knotless, medium length leather whip with a single tip. Men had to be stripped of clothing because clothing could create a barrier to pain, and they were to be whipped all over their body. For women the lashes fell only on the back and shoulders. The lashes could not be so severe as to cut the skin or threaten the life of the victim, but not so weak that they did not inflict severe pain.

Because of the consequences, Muhammad set a high evidentiary bar for adultery. Four pious upright witnesses were required, and anyone making a false accusation or even accusations that could not be proven would face the whip. "Give me the evidence, or the punishment will be on your back," Muhammad warned accusers. The witness rule was inspired by the rumours of infidelity that had circulated about Aisha. There had not been any witnesses; it was all circumstantial. She had been left behind on the return trip from the Mustaliq raid; Safwan had rescued her and brought her back in full view of the army, yet tongues wagged. Muhammad punished the men and women who spread the rumours, setting the precedent for what would happen to anyone who made false accusations or accusations that could not be proven.

The requirement for witnesses had a downside however. One man who caught his wife in flagrant complained to Muhammad he did not have enough time to round up witnesses. When Muhammad threatened him with the whip, the man raised his hands heavenward and appealed to God for help. His back was spared when Muhammad came up with several verses to deal with such situations.¹⁸ The solution involved an oath: He had the woman in this particular matter brought before him and made the husband state the accusation to her face four times and then take an oath to God as to its veracity. Then the woman, who knew she would die by stoning if she confessed, swore vehemently four times that her husband was a liar and made an oath in God's name as to her truthfulness. Thus Muhammad washed his hands of it: God would punish the one who lied in the next life.

It was not only the whip and the stone that encouraged compliance to the new law, but also the threat of hellfire. Muhammad equated sex outside of marriage with sin, an offense against God, and God was wrathful with sinners. God would throw the wicked into the pits of Hell and slam the furnace doors shut forever. With sadistic detail, Muhammad used to describe tortures awaiting the damned. The scenes were so gruesome the faithful would sometimes openly weep. Punishment in this life was purification, he told them, and it was less severe than the punishment of the next life. If they accepted punishment in this life with repentance, Allah would forgive them in the next.

What Muhammad accomplished by equating adultery and fornication with evil was to create sexual guilt and hysteria where it had not previously existed. This can be seen in anecdotes where people confessed their sexual sins to Muhammad, hoping to obtain from him the purification of punishment in this life to avoid the eternal fire in the next. The story is told of a man named Maiz who came before Muhammad to confess to adultery. "I earnestly desire that you should purify me," he said. At first, Muhammad turned away from him, perhaps not wanting to let it go any further, but each time he turned away the man moved so that he stood in front of him and repeated

his self-accusation. After he did it for the fourth time, Muhammad said, “Are you insane?” When he replied that he was not, Muhammad sent people to make inquiries about him. Once it was determined he was mentally competent, he ordered his death. It is said they took him out to the execution site where a crowd hurled stones at him, but he became frightened and broke free. The frenzied crowd chased him to the lava fields on the west side of the valley. “I was among the ones who participated in stoning him,” reported Jabir Abdullah, a prominent believer. “When the stones troubled him, he fled, but we overtook him at the lava field and stoned him to death.”


A similar case involved a woman. She was a married woman who confessed to an affair, but Muhammad at first rebuffed her. She returned one day and said she was pregnant, proof of her sin, and asked to be purified through punishment. “If you insist,” Muhammad said. The execution was delayed until she delivered, but even then Muhammad gave her another two years to nurse the child. When it was weaned she came before him carrying the child, who was holding a piece of bread. Muhammad turned the child over to someone and ordered her death. Her execution was done differently: She was buried up to her chest so that she could not run away. The crowd hurled stones at her head until the life was gone from her.

Before he died, Muhammad ended up formulating rules that regulated nearly every aspect of life as it was then lived in the frontier region of Arabia: real estate, money lending, inheritances, sharecropping, the buying and selling of dates, date trees, and animals—all were matters he concerned himself with. He ruled on how to defecate, how to wash, how to dress, how to address people, what to eat, and what not to eat. Marriages, births, and funerals all had the stamp of his rules. He forbade music, singing, and dancing as idle activities that took people from the path of God. He devoted attention to ruling on the minutiae of the prayer rituals, pilgrimages, and the sacrificing of animals, all of it ending up as formulas for the faithful. What became Muhammad’s law was a combination of Koran

verses and his Sunna—his “legal ways,” essentially meaning what he himself did in every situation, whether it was a formal pronouncement or merely the example of his behaviour. This amalgamation was called then, and it is still called today, the Sharia, from the word for path. Walk along the path paved with the flagstones of Muhammad’s verses and personal example and surely you will reach Paradise.


Sharia law pointers


What We Need to Know about Sharia's Law:

When reading this just keep in mind that **Islam is NOT looking for acceptance**, they are looking for dominance!

1. Jihad, defined as "to war against non-Muslims to establish the religion," is the duty of every Muslim, and Muslim head of state (Caliph). Muslim Caliphs who refuse jihad are in violation of Sharia and unfit to rule.
2. A Caliph can hold office through seizure of power meaning through force.
3. A Caliph is exempt from being charged with serious crimes such as murder, adultery, robbery, theft, drinking & in some cases of rape.
4. A percentage of Zakat (charity money) must go towards jihad. Also called Jizya; money we pay on Halal certified food, drink & services, including financial services / banking etc.
5. It is obligatory to obey the commands of the Caliph, even if he is unjust.
6. A caliph must be a Muslim, a non-slave, and a male.
7. The Muslim public must remove the Caliph if he rejects Islam.
8. A Muslim who leaves Islam could be killed immediately.
9. A Muslim will be forgiven for murder of
 - I. An apostate.
 - II. An adulterer.
 - III. A highway robber.
 - IV. Vigilante street justice and honour killing is acceptable.
10. A Muslim will not get the death penalty if he kills a non-Muslim, but can get it for killing a Muslim.
11. Sharia never abolished slavery, sexual slavery and highly regulates it. A master (owner of a slave) will not be punished for killing his slave.
12. Sharia dictates death by stoning, beheading, amputation of limbs, flogging even for crimes of sin such as adultery.
13. Non-Muslims are NOT equal to Muslims under the law. They must comply with Islamic law if they are to remain safe.
 - .. they are forbidden to marry Muslim women, publicly display wine or pork, recite their scriptures or openly celebrate their religious holidays or funerals.
 - .. they are forbidden from building new churches or building them higher than mosques. They may not enter a mosque without permission.
 - .. a non-Muslim is no longer protected if he leads a Muslim away from Islam.
14. It is a crime for a non-Muslim to sell weapons to someone who will use them against Muslims. Non-Muslims cannot curse a Muslim, say anything derogatory about Allah, the Prophet, or Islam, or expose the weak points of Muslims, but Muslims can curse non-Muslims.
15. A non-Muslim cannot inherit from a Muslim.
16. Banks must be Sharia compliant and interest is not allowed.
17. No testimony in court is acceptable from people of low-level jobs such as street sweepers or bathhouse attendants. Women in low level jobs such as professional funeral mourners cannot keep custody of their children in case of divorce.



18. A non-Muslim cannot rule -- even over a non-Muslim minority.
19. Homosexuality is punishable by death.
20. There is no age limit for marriage of girls. The marriage contract can take place any time after birth, and can be consummated at age 8 or 9.
21. Rebelliousness on the part of the wife nullifies the husband's obligation to support her, gives him permission to beat her and keep her from leaving the home.
22. Divorce is only in the hands of the husband and is as easy as saying: "I divorce you" and becomes effective even if the husband did not intend it.
23. There is no community property between husband and wife and the husband's property does not automatically go to the wife after his death.
24. A woman inherits half what a man inherits.
25. A man has the right to have up to 4 wives and none of them have a right to divorce him -- even if he is polygamous.
26. The dowry is given in exchange for the woman's sexual organs.
27. A man is allowed to have sex with slave women and women captured in battle, and if the enslaved woman is married her marriage is annulled.
28. The testimony of a woman in court is half the value of a man.
29. A woman loses custody if she remarries.
30. To prove rape a woman must have 4 male witnesses.
31. A rapist may only be required to pay the bride-money (dowry) without marrying the rape victim.
32. A Muslim woman must cover every inch of her body, which is considered "Awrah," a sexual organ. Not all Sharia schools allow the face of a woman exposed.
33. A Muslim man is forgiven if he kills his wife at the time he caught her in the act of adultery. However, the opposite is not true for women, since the man "could be married to the woman he was caught with."
34. It is obligatory for a Muslim to lie if the purpose is obligatory. That means that for the sake of abiding with Islam's commandments, such as jihad, a Muslim is obliged to lie and should not have any feelings of guilt or shame associated with this kind of lying; just a few points to consider when next discussing this ideology with a Muslim or a 'supporter / sympathiser' of Islam.
