## **AOA Secures Eleventh - Hour Red Flags Rule Enforcement Delay**

Facing mounting pressure from AOA and others, the Federal Trade Commission (FTC) has announced today that it will once again postpone enforcement of the Red Flags Rule, this time through Dec. 31, 2010. The FTC was scheduled to begin enforcement of the Rule June 1, 2010. However, AOA continued

to pressure agency officials and urge key members of Congress to provide a permanent exemption for optometry practices and, ultimately, to secure the latest enforcement delay.

The May 28 announcement was the fifth consecutive delay and appears to signal an understanding

on the part of the FTC that Congress is moving closer toward providing permanent relief for small business health care practices. Work will continue to secure a much needed permanent exemption.

The U.S. House has already approved AOA-backed legislation (HR 3763) sponsored by Rep. Adler (D-NJ) that would exempt small business optometry and other health care practices with 20 employees or fewer from Red Flags requirements. However, Rep.

Adler's bill has stalled before the U.S. Senate Banking Committee.

Within the past week, companion legislation to Rep. Adler's bill has been introduced into the U.S. Senate (S. 3416) by John Thune (R-SD). AOA will use this added

time to advance these bills and help ensure that Congress follows through on promises made and ultimately fixes the Red Flags issue. In a press release this morning, FTC Chairman Jon Leibowitz said "Congress needs to fix the unintended consequences of the legislation establishing the Red Flags Rule — and to fix this problem quickly. We appreciate the efforts of

Congressmen Frank and Adler for getting a clarifying measure passed in the House, and hope action in the Senate will be swift."

## LEGISLATIVE UPDATES: BY DR. ANNETTE HANIAN

#### SB1285

SB 1285 was passed into law and becomes effective July 29th, 2010. You can look at our Optometry Statutes and Rules anytime online at: <a href="https://www.optometry.az.gov">www.optometry.az.gov</a>.

I encourage you all to visit the site and be familiar with our professions limitations and restrictions. Make sure that you are practicing in compliance with Arizona law.

#### **AOA Advocacy Conference Report**

Dr. Rand Siekert AOA-PAC, Dr. Shannon Steinhauser President-Elect and Dr. Annette Hanian AOA Federal Keyperson Coordinator attended the Annual AOA Advocacy meeting in Washington DC March 3-4th on behalf of Arizonans. We learned of the Federal AOA backed legislation that is currently being worked on. We visited with the offices of both our Senators and 7 of the 8 Congresspersons. We were able to discuss with some of the Legislators and all of their Legislative Advisors about Optometry and the Legislation that affects how and where we practice.

The AOA is backing the following bills:

## HR 1884: National Health Service Corps Improvement Act:

Which would expand access to eye and vision care

through community health centers and offer loan payback alternatives for recent OD graduates.

#### HR 2697: Optometric Equity in Medicaid Act:

Which would require full recognition of Optometrists in Medicaid.

#### HR 4360: Honor Fallen Army Optometrist:

Which would name a CA VA blind rehabilitation center after Major Charles Robert Soltes, OD.

#### S 259: Vision Care for Kids Act:

Which would establish grants to the state's to bolster children's vision and learning initiatives.

## IN THE NEWS

#### Medicare Payment Update - June 16, 2010

Following up on the most recent Medicare payment update from the AOA Washington Office, the notice below from CMS details the steps the agency is taking with regard to the 21% fee cut that Congress allowed to take effect on June 1st. Right now, a broad tax and social program extender bill (HR 4213) remains under consideration in the U.S. Senate and it does includes a measure of relief from these cuts through 2012, an improvement over the monthly extensions passed in March and April but far short of the long-term payment reform that is needed and that AOA is supporting.

Please note that CMS – citing the debate now taking place on Capitol Hill – has now instructed its contractors to extend the hold on claims through Thursday, June 18th. The AOA is continuing to push for immediate and long-term corrective action through meetings with Members of Congress and their aides to report on the severe impact of Medicare payment instability on ODs and their patients across the country.

The 2010 Medicare Physician Fee Schedule - From CMS

The Continuing Extension Act of 2010, enacted on April 15, 2010, extended the zero percent (0%) update to the 2010 Medicare Physician Fee Schedule (MPFS) through May 31, 2010. At this time, Congress is debating the elimination of the negative update that took effect June 1, 2010. The Centers for Medicare & Medicaid Services (CMS) is hopeful that Congressional action will be taken within the next several days to avert the negative update.

To avoid disruption in the delivery of health care services to beneficiaries and payment of claims for physicians, non-physician practitioners, and other providers paid under the MPFS, CMS had instructed its contractors on May 27th to hold claims for services paid under the MPFS for the first 10 business days of June (i.e., through June 14, 2010). This hold only affects MPFS claims with dates of service of June 1, 2010, and later.

Given the possibility of Congressional action in the very near future, CMS is now directing its contractors to continue holding June 1 and later claims through Thursday, June 17, lifting the hold on Friday, June 18.

This action will facilitate accurate claims processing at the outset and minimize the need for claims reprocessing if Congressional action changes the negative update. It also should minimize the provider and beneficiary burdens and costs associated with reprocessing claims.

We understand that the delayed processing of Medicare claims may present cash flow problems for some Medicare providers. However, we expect that the delay, if any, beyond the normal processing period will be only a few days. Be on the alert for more information regarding the 2010 Medicare Physician Fee Schedule Update.

## **Historical Note: AOA Congress of 1910**By Irving Bennett, O.D.

Those of us who are interested in history think a lot about what happened 100 years ago. With the AOA's 113th convention occurring in Orlando, FL this summer, we can't help but conjecture on what transpired at the AOA Congress a century ago. The brief answer: a lot.

The meeting was held in Cedar Point, Ohio in August 1910, the year following a gubernatorial veto of the legislation that would have created an Ohio Optometry Law. This was a major setback for the fledgling Ohio association and the members of AOA all over the nation vowed to do something about it. The Ohio and American Medical Associations were so confident of their political prowess that, according to the book, American Optometric Association – a History, by deceased OD and prolific author James R. Gregg\*, they openly told Ohio Governor Harman "if you have any Presidential aspirations, you will have us, the strongest political organization in America, to reckon with."

The AOA Convention of 1910 registered 310 members and changed the name of the national association from the American Association of Opticians to the American Optical Association. It was still too daring to use the word "optometrist" in the name – although efforts to do so came close to success.

## Twelve States, Including Arizona, to Receive Federal Matching Funds for Electronic Health Record Incentives Program

In another key step to further states' role in developing a robust U.S. health information technology (HIT) infrastructure, the Centers for Medicare & Medicaid Services (CMS) announced today additional federal matching funds for certain state planning activities necessary to implement the electronic health record (EHR) incentive program established by the American Recovery and Reinvestment Act of 2009 (Recovery Act).

The Recovery Act provides a 90 percent federal match for state planning activities to administer the incentive payments to Medicaid providers, to ensure their proper payments through audits and to participate in statewide efforts to promote interoperability and meaningful use of EHR technology statewide and, eventually, across the nation.

EHRs will improve the quality of health care for the citizens of the recipient states and make their care more efficient. The records make it easier for the many providers who may be treating a Medicaid patient to coordinate care. Additionally, EHRs make it easier for patients to access the information they need to make decisions about their health care.

This batch is part of a rolling announcement CMS began in November 2009. To date, including the new states, we will have awarded a total of \$43.56 million., of which Arizona received \$2.89 million.

An educational program of the National Healthy Mothers, Healthy Babies Coalition (HMHB), text4baby delivers timely health tips via text message to those who need it most. It is made possible through an unprecedented public-private partnership which includes the White House Office on Science and Technology Policy, the U.S. Department of Health and Human Services,

Voxiva, CTIA-The Wireless Foundation, Grey Health-care Group (a WPP company) and founding corporate sponsor Johnson & Johnson. Premier sponsors include WellPoint, Pfizer and CareFirst BlueCross BlueShield and wireless carriers are distributing text messages at no charge to recipients. Implementation partners include BabyCenter, Danya International, Syniverse Technologies, Keynote Systems and The George Washington University.


