TRIAL INFORMATION

This trial will be held indoors on rubber over padding. The following is a list of obstacles to be used. Contacts have rubber coating. 2" jumps will be obtained by crossing bars on the 4" jump cups.

A-frame (6' 8" slatless) *Closed (Collapsed) Tunnel* *Tire Jump (16")* *Dog walk (8' slatless ramps)* *Table (30" by 30")*
Open (Pipe) Tunnel (16") *Single & winged jumps* *Teeter (8' slatless, 12" wide)* *Weave poles (22" centers)*

A warm up area with TDAA equipment provided for all exhibitors. Obstacle familiarization is available each morning prior to judging.

Awards: Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying score. Dogs may receive placement ribbons without qualifying. Fast track dogs will only get Qualifying ribbons at the Beginners/Games I and Intermediate/Games II levels.

PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS

All dogs must be kept on leash except in designated areas

Eligibility: This trial is open to all dogs under 20" and over the age of 12 months, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Your dog must be registered with TDAA to participate in TDAA Trials. There is a registration form included in this premium, or you can register the first day of the trial. TDAA rules can be obtained online at www.k9tdaa.com

GAMES DESCRIPTIONS

Call or email if you have any questions about these games – they're not hard!

Black Hole – Black Hole is like a standard course. The handler will direct the dog on the numbered course. The dog can continue to earn points unless the dog goes into a pipe tunnel (the black hole). Scoring stops once the dog goes off-course into a tunnel.

Salmon Run – is a game of strategy and daring. The objective is to get from the ocean to the spawning area while performing as many obstacles as possible on the way without ever stopping, going back to correct a missed obstacles, or without allowing the dog to ever cross over his own path. One point is earned for each obstacle performed!

April's Fool – Come with your sense of humor! This numbered course has a twist. Before each team runs, they turn their back to the course. A runner will go out on course and mark two obstacles with an "April's Fool" sign, and those obstacles must be skipped during the run! The course will be different for each dog/handler team.

Stay Out of Jail – is a simple sequencing game where the dog is sent to jail (the table) for any performance faults. In this variation, the field of competitors is divided into two teams with individual run times combined for a team score. Individual runs count as qualifying scores. (Note: 2 separate courses will be run side-by-side with a barrier down the middle. Only one dog is on each course at a time, but 2 dogs are running simultaneously.)

CLASS INFORMATION

Standard Agility Class

Beginner All dogs shall be eligible for participation in this class.

Intermediate Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

Superior Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

Games Classes

Games I All dogs shall be eligible for participation in this class.

Games II Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

Games III Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

FEO (FOR EXHIBITION ONLY) – Games & Standard Classes

TDAA offers FEO runs (at the option of the host club), open to any TDAA registered dog in any class. FEO dogs will run last at their jump heights. They may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. Maximum time of 1.5 of the SCT, cannot repeat any obstacles, and no training in the ring.

Fast Track Move-Ups: Titles may be grandfathered from other organizations on a "Fast Track" basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move from Beginner to Superior on the same day if the dog qualifies first in Beginner and again in Intermediate. Likewise, a dog may move from Games I to Games III by qualifying at each of the lower two levels. A qualifying score in the lower class is required to move up to the next higher class. The dog's owner must submit a copy of title certificates for the dog. Please mark each that apply and submit \$8.00 with your entry with the FAST TRACK portion completed. Payment of the \$8.00 is not a guarantee that your dog will qualify at the lower level and is non-refundable. This fee must be paid for this trial even if a Fast Track fee has been paid in the past.

HEIGHT DIVISIONS - See www.k9tdaa.com for updates to Rules and height divisions!

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division (and scored in that higher height division) A judge must measure provisional dogs.

New rules effective January 1, 2015:

- **Handler/Owner selects jump height** – Each handler may select the jump height they wish their dog to jump. All jump height exemptions are now removed. Dogs will continue to be scored with dogs at their measured height.
- **Removal of four-paw safety rule** – a Beginner dog will no longer be required to move on after committing four paws to an obstacle and leaving. Beginner dogs will have three chances to perform a contact obstacle, and will not be faulted until a third on-and-off refusal.
- **Additional time for Veteran Dogs and Disabled Handlers will still apply.**
 - Veteran Dogs (7 yrs and older) receive an extension of standard course time
 - Measured height of 2" & 4" dogs receive an additional 4 seconds
 - Measured heights of 8", 12" & 16" dogs receive an additional 2 seconds
 - Disabled Handlers receive an extension of 4 seconds to standard course times and qualifying course times for games.

Please consult your jump height card/email to confirm the correct measured height to enter.

If you do not have a TDAA height card/email your dog must be measured at this trial.

Disabled Handlers – A time exemption will be granted as above. The proof of the disability shall be the handler's disability parking tag or other documentation. There will be no special system of titling for disabled handlers.

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * All dogs must be on leash or crated at all times except when in the ring or when in designated areas, being the warm-up area and the designated off leash area. It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial Committee, be asked to leave the trial site. In such case, no refund of any fees will be made.
- * Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- * Exhibitors are responsible for being at the ring gate when it is their turn to run.
- * Exhibitors may wear shirts or insignia of their training group if they wish.
- * At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- * Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at www.k9tdaa.com
- * Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- * **Photocopied entries without the TDAA agreement are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- * The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- * No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.
- * Bitches in season are not permitted in the trial. Full refund for bitches in heat if notification is sent to the Trial Secretary in writing (E-mail OK) no later than the Friday before the trial.

VOLUNTEER SIGN UP

Volunteers are the backbone of any agility trial. We need all hands to make a trial work. **Please sign up on the volunteer board at the trial to work during classes you are not running in.** We will make sure you get adequate time to warm up your dog and do your walk-through. We'll make sure you are instructed on how to do a job, and it's actually fun and you learn a lot getting a different view of the trial and different handlers!

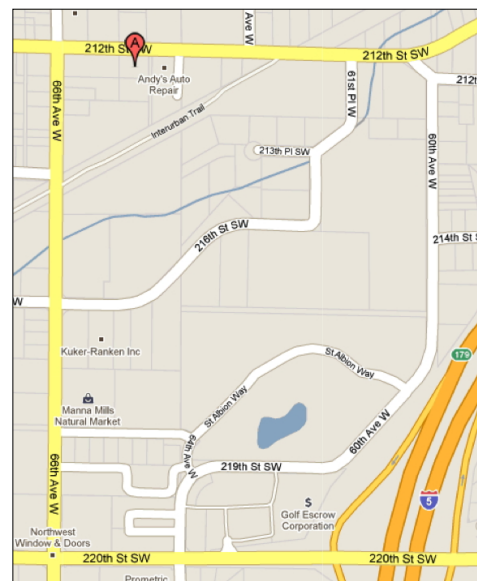

DIRECTIONS TO THE FACILITY:
