2017 WTF/ PATU G-Event Coach Permit

October 27, 2016 Portland, Oregon USA

Beginning January 2017, WTF is mandating all Kyorugi and Poomsae coaches to hold WTF/PATU G-Event Coach Permit at all WTF G-Rank events. The WTF/PATU Coach Permit will replace the current Intercontinental Coach License previously issued by all Continental Unions and will allow Coach Permit holders to coach at any and all WTF G-Events, effective immediately until December 31, 2017.

Current 2016 Intercontinental Coach License will remain valid until its expiration date.

Coaches who do not hold current Intercontinental Coach Licensure and coaches whose Intercontinental Coach License are due to expire within the next two months are highly encourage to take advantage of this opportunity to seek 2017 WTF/PATU G- Event Coach Permit through this training. Participants of this Permit Training will be issued WTF/PATU G-Event Coach Permit, valid through December 31, 2017.
