

FORBES ROTARY IPOMOEA CHARITY FUN RUN TERMS & CONDITIONS



1. I acknowledge that running and walking involves the real risk of injury or death from various causes, which may include but is not limited to, over-exertion, dehydration, heart problems, disorientation, accidents with other competitors, spectators, volunteers or road users; equipment failure, unforeseen events; the course, or the weather conditions.
2. I understand that I should not compete in this event unless I have trained appropriately and a medical practitioner has verified my medical condition.
3. By competing, I accept all risks necessarily flowing from my participation that could result in injury or death. Accordingly, I release all people associated with the conduct of the event from, and will indemnify them against, all liability (including liability for their negligence) for any and all injury, loss or damage arising out of, or connected with my, participation in this event. For clarification, the people released include event organisers, sponsors, managers, government and public authorities, contractors, volunteers and event medical and paramedical personnel. This release and indemnity is perpetual and binds my heirs, executors, personal representatives and assigns.
4. I consent to receiving any medical treatment that event organisers or medical or paramedical personnel believe is necessary for my health before, during or after the event.
5. I understand that the event organizer does not provide health insurance for me, and I will bear all financial responsibility for all and any medical treatment arising from my participation in this event; including but not limited to ambulance, doctor and hospital fees. I understand that I should have my own personal accident and ambulance cover.
6. I am fully responsible for the security of my personal possessions at the event.
7. I agree to abide by all race rules and direction issued by the event organisers.
8. By entering this event, you consent to your personal information being provided to Athletics Australia Ltd and 'state association' for the purpose of registering you as a recreational running class of member of 'state association' and for administering the Running Australia program. You further consent to receiving information (including via email) about the Running Australia program, including details of other events and special offers or promotions. If you DO NOT consent to your personal information being disclosed and used in this manner, or receiving information about the Running Australia program, please contact the Forbes Rotary Ipomoea committee.
9. Entry information is to be collected into a database which is, and shall remain, the property of the Forbes Rotary Ipomoea committee.
10. The database will be used in the management of the race and for the purpose of the Forbes Rotary Ipomoea committee.

12. I acknowledge that the information given on this form or otherwise provided by me (or my parent/s or guardian/s) to the Forbes Rotary Ipomoea committee is true and correct.
13. I acknowledge that photos may be taken throughout the Forbes Rotary Ipomoea Charity Fun Run that may be utilized for promotional purposes.
14. Each competitor will run on the approved course as directed, and will not accept outside assistance.
15. The organisers reserve the right to delay, alter or cancel any race in the event of dangerous weather conditions.
16. The organisers cannot be held responsible for lost or stolen valuables.
17. The organisers reserve the right to make additions, changes or clarifications of these Terms & Conditions without prior notice to participants. The organisers will endeavor to advise participants of any rule change prior to the race, but any such change shall be considered effective for all the participants whether or not the participant has received notice of the change prior to the race.
18. All decisions of the Fun Run Coordinator (or delegate) are final. The Fun Run Coordinator (or delegate) is the sole judge of the fact; there is no right of appeal regarding any decision made by the race director.
19. The Fun Run Coordinator (or delegate) reserves the right to reject or disqualify any participant whose conduct is inappropriate to the spirit of the race. Individual disqualifications may lead to the entire team (if applicable) being disqualified. It is expected each participant competes in the appropriate spirit.
