Illustrated Instructions:

STEP 1 of 2 * Once you have completed tryouts step #2 will be to upgrade your membership

1. Go to the Puget Sound Region Website – www.psrvb.org
2. Click on the 'Membership' tab at the top.
3. Select either 'Returning Member' or 'New Member'

Junior Membership Types

Junior U8 Membership - \$0
For athletes who qualify for the U8 age division of USA Volleyball.

Junior U11 Membership - \$15
This membership is available for athletes who qualify for the U11 age group of USA Volleyball. This membership should be purchased instead of the junior tryout membership for athletes who will compete on club teams that do not travel outside of the Puget Sound Region. Athletes on teams traveling to PNQ in Spokane, or any other out of Region event, must have the full junior membership.

Junior Tryout Membership - \$5
This membership is required for athletes participating in club volleyball tryouts. This membership must be upgraded to a full junior membership after the club contract is signed.

Junior Tryout Membership Upgrade - \$67
This is the second step of the two step junior membership process for club volleyball players. After the player signs a club contract, this membership must be purchased for the athlete to be eligible for USA Volleyball participation.

Full Junior Member - \$72
This membership is required for every athlete joining a club volleyball program after December 15.

Limited Junior Membership - \$27
This membership is for athletes participating in clinics or camps, but not in full club volleyball and tournaments.

Fall League Membership - \$10
This membership is for athletes new to USA Volleyball participating in fall training programs. This membership expires on October 31 and does not take the place of the Junior Tryout Membership.
