

EMERGENCY PETITION DISCLOSURE

I understand that once I have obtained the above documents, I will need to schedule an appointment to complete and sign the remainder of my bankruptcy petition. If I fail to do so, the Hurst Law Firm will be unable to complete the filing of my bankruptcy petition and my case will be dismissed.

Finally, I/we understand that, until my/our petition is filed with the Bankruptcy Court, I/we am/are not protected from collection activity by my/our creditors including, but not limited to: foreclosure, repossession, eviction, garnishments, lawsuits, phone calls. I also acknowledge that the Hurst Law Firm has advised me to attend the foreclosure sale of my property, if it has already been set, in order to be certain the mortgage creditor has notice of the bankruptcy case filing prior to the scheduled foreclosure sale.
