

## Wix SEO HERO CONTEST RULES (the “Rules”)

- **THIS CONTEST IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK OR GOOGLE.**
- **THIS IS A SKILL-BASED CONTEST.**

Important: Please read these Rules before entering this Contest. By participating in this Contest, you agree to be bound by these Rules.

### 1. SPONSOR

The Contest is sponsored and held by Wix.com, Ltd. (with its worldwide affiliated companies - “**Wix**” or “**Sponsor**”), having its principal offices at 40 Namal Tel Aviv Street, Tel Aviv, Israel. This Contest is in no way sponsored, endorsed or administered by, or associated with Facebook or Google Inc..

### 2. ELIGIBILITY

2.1. The Wix SEO Hero Contest (the “**Contest**”) is open only to persons or entities (“**Participant/s**”) who (i) if are individuals: (A) are legal residents and are physically located and reside in a jurisdiction in which this type of contest is permitted; and (B) have reached the age of majority in their jurisdiction of residence at the time of entry; or (ii) if are entities - are legally incorporated in a jurisdictions in which this type of contest is permitted for entities. For the avoidance of doubt, Sponsor and any of its employees are also eligible to participate in the Contest. Employees of Moderator (as defined below), its parent, affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers, directors, officers, and each of their immediate family members and/or those living in the same household of each are not eligible to enter the Contest.

2.2. Persons or entities who are (1) residents of or incorporated in US embargoed countries, (2) ordinarily residing or operating in US embargoed countries, or (3) otherwise prohibited by applicable export controls and sanctions programs, are not eligible to participate in the Contest.

### 3. PURPOSE OF CONTEST

The Contest is targeted to determine which of the Hero Websites (as defined below) that participate in the Contest, is ranked first among all Participants on Google's organic search (excluding local search results) when searching the term "SEO HERO", at the end of the Contest, pursuant to the assessment procedure described in these Rules.

### 4. CREATING THE HERO WEBSITE; GOOGLE ACCOUNTS

4.1. Each Participant must create their own website (the “**Hero Website**”). Each Hero Website must comply with the following terms:

4.1.1. The domain name of the Hero Website is to be registered by the Participant on or after November 16, 2016.

4.1.2. The Domain name must be new and may not be obtained by way of resale or transfer of an already registered domain name. Participants may not use expired or mature domain names or alike. Participants are encouraged to keep evidence of their registration process to demonstrate, if so requested by the Moderator, compliance with this Section 4.1.2.

- 4.1.3. The Hero Websites must be created, maintained and promoted in compliance with the Google Guidelines for SEO published at <https://support.google.com/webmasters/answer/35769?hl=en> (the "**Guidelines**"). Any activity in violation of the Guidelines may disqualify the Participant and its respective Entry from participating in the Contest.
- 4.1.4. The content of the Hero Website must be in English
- 4.1.5. The Hero Website (including the domain name) can be dedicated to the Participant's SEO hero (i.e. a Search Engine Optimization expert who is respected and esteemed by the Participant) and must not contain content that (i) is sexually explicit, violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; (ii) promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing) or a particular political agenda; (iii) is obscene or offensive; (iv) defames, misrepresents or contains disparaging remarks about other people or companies; (v) contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others without the proper license or consent; (vi) violates the rights of any other person or entity by using their names or images, or featuring or referring to any recognizable person, without such person's informed consent thereto; (vii) violates copyrighted materials owned by others (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media); (viii) content that denigrates, disparages or reflects negatively on the Sponsor; and/or (x) violates any law or any legal terms applicable to such Entry, including the Facebook terms of service.
- 4.2. In addition, each Participant must (i) open, prior to February 16, 2016, accounts in Google Analytics and Google Search Console, which will be associated with the Hero Website; and (ii) provide administrative rights to the Moderator's (as defined below) email, which is: [judgetwixseohero@gmail.com](mailto:judgetwixseohero@gmail.com).
- 4.3. Failure by Participant to comply with the terms of this Section 4 shall cause an automatic disqualification of such Participant from the Contest with no right to appeal and no notice shall be required to be provided to Participant of such disqualification by Sponsor and/or by Moderator.
- 4.4. It is each Participant's responsibility to verify that the Hero Website they create is in compliance with any applicable law and does not violate or infringes upon any rights of third parties and that Participant owns all rights and title, or otherwise has (and will continue to have) the full power, licenses, consents and authority necessary to create the Hero Website and to include in it the content presented therein. Participants may approach their SEO hero and request his/her permission to use their likeness or other features for the Contest, as Sponsor did.

## 5. **HOW TO ENTER**

- 5.1. Entries (as defined below) may be submitted from 09:00:00A.M. Eastern Time ("ET") on November 16, 2016, through 11:59:59 P.M. ET on December 16, 2016 (the "**Entry Period**").

- 5.2. Entries may be submitted from the Contest Landing Pages which can be found here: <http://www.wix.com/wix-lp/seo-heroes> and here <http://wix-lp.wix.com/seo-heroes-combined> (each and together: the "**Contest Page**").
- 5.3. To enter the Contest, you must submit your Entry, during the Entry Period, as follows:
  - 5.3.1. Enter the Contest Page and fill in the submission form available on the Contest Page by completing the following details: (i) Name; (ii) Email; (iii) Phone number; (iv) Hero Website URL; and any other detail which may be required by Sponsor in the submission process.
  - 5.3.2. To complete your submission you must agree to these Rules and submit your Entry by pressing the "Send" button.
- 5.4. Upon receipt by Sponsor of your successfully completed submission in accordance with these Rules, you shall be considered as having submitted an entry to the Contest ("**Entry**" or "**Entries**"). An Entry is "received" when the Entry is uploaded to the Contest Page. Proof of submitting an Entry will not be deemed to be proof of receipt by Sponsor or proof of compliance with the Rules.
- 5.5. Participants are free to upload and publish their Hero Website at any time prior to the conclusion of the Contest, on March 16, 2017. However, this does not derogate from the requirement to enter the Contest during the Entry Period.
- 5.6. Sponsor has no obligation to advise you of an incomplete or otherwise non-compliant Entry. You are solely responsible for internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- 5.7. Entries will be deemed to be made by the person or entity whose domain name is provided in the submission form submitted via the Contest Page. In the event of a dispute relating to ownership of the winning Hero Website, Sponsor and/or Moderator may require the potential winner to provide proof that they are the authorized holder of the domain name of the Hero Website, and consequently of the winning Hero Website. Sponsor shall be entitled to use its best judgment, in its sole discretion, to determine the rightful owner of the winning Hero Website. Sponsor may run multiple campaigns, contests, sweepstakes or other promotions simultaneously and Sponsor is not responsible for Entries incorrectly posted on the Contest Page.
- 5.8. Each Participant may submit more than one (1) Entry but no more than five (5) Entries, provided each Entry contains a Hero Website with a different domain name.
- 5.9. You are not required to "like" or follow the Wix FB Page or to place any purchase with Wix in order to participate in the Contest or be eligible for the Prize.

## 6. **CONDUCT DURING THE INTERIM PERIOD; MODERATOR**

- 6.1. During the period between the submission of the Entry and the announcement of the Winner (as defined below) (the "**Interim Period**") each Participant:
  - 6.1.1. May decide on the exact time in which their Hero Website becomes public; and
  - 6.1.2. Shall comply with the Guidelines when promoting the Hero Website.

- 6.2. In addition, each Participant shall receive from the Moderator access to a designated folder on Google Docs, in which he/she will be able to upload the content of their Hero Website, as soon as such content is created. Participants are not obligated to upload their content. However, in case of any dispute regarding compliance with the Guidelines, Participants who have been uploading such content shall have the right to use the content of the folder as evidence to the truthfulness of their claims and in case of dispute, their claims shall supersede the claims of such Participants who have not been uploading their content, unless otherwise demonstrated.
- 6.3. Sponsor shall have the right to track the Hero Websites' rankings and publish their position.
- 6.4. An outside professional- Mr. Eran Hurvitz, CEO of MRKT360 INC - shall preside as the Contest Moderator (the "**Moderator**").
  - 6.4.1. The Moderator shall be responsible for:
    - 6.4.1.1. Reviewing, at his sole discretion, any Hero Website he chooses, for non-compliance with the Guidelines and with the terms of Section 4 (the "**Non-Compliance**");
    - 6.4.1.2. Determining, at his sole discretion, if a reviewed Hero Website is in violation of the Guidelines and/or Section 4 (the "**Non-Complying Website**");
    - 6.4.1.3. Determining, at his sole discretion, that a Non-Complying Website should be disqualified; and
    - 6.4.1.4. Issuing any notices to the Participants in connection with Non-Compliance and performing any activity in connection with his responsibilities as described in this Section 6.
  - 6.4.2. The Moderator may review any Hero Website either at his own initiative or if requested so by any other party.
  - 6.4.3. The Moderator may suspend any review of Non -Compliance, if no sufficient available means are at his disposal in order to determine whether or not Non-Compliance has occurred. In such event the respective Hero Website shall be deemed to be in compliance with the Guidelines.
  - 6.4.4. In his review, the Moderator may use any resources and procedures he deems fit. The Moderator may also request to receive additional information from the respective Participants or from other parties.
  - 6.4.5. If the Moderator reaches the conclusion that a Hero Website is a Non-Complying Website then:
    - 6.4.5.1. The Moderator shall communicate his decision to the Participant who has entered the Non-Complying Website to the Contest and inform him/her that their Hero Website is in Non-Compliance. Moderator shall not be required to provide the reason for the disqualification.
    - 6.4.5.2. The respective Participant may appeal the Moderator's decision within 10 business days as for receipt of notice thereof (the "**Appeal Period**"), provided that as of February 24, 2017, the Appeal Period shall be only 3 business days as of receipt of

Moderator's decision and in any event no appeals shall be submitted after March 15, 2017. When appealing, Participants may provide evidence to the truthfulness of their claims while using an appeal form which will be provided to them by the Moderator.

- 6.4.5.3. In the event the Participant does not appeal within the Appeal Period, Moderator shall inform Sponsor that such Participant has been disqualified from the Contest.
- 6.4.5.4. In the event the Participant does appeal within the Appeal Period, Moderator shall review the appeal and shall provide a final binding decision once his review is completed. Moderator may use any means at his disposal to review the appeal and reach a decision. The Moderator shall not be required to provide any justification for his decision.
- 6.4.6. In the event the Moderator determines that the appeal should be rejected, he will so notify the Participant and the Participant shall be disqualified from the Contest. The Moderator shall inform Sponsor of such disqualification. In the event the Moderator determines the appeal should be approved he shall so notify the Participant.
- 6.4.7. The Moderator shall have right to take any administrative actions (including retaining additional personnel on his behalf in order to handle administrative issues) and determine administrative procedures which may be required in order to enforce his powers and responsibilities as described above.
- 6.4.8. It is each Participant's responsibility to protect their site from any outside attack or disturbance and neither Sponsor nor Moderator shall be responsible for eliminating such attacks, finding the causes for such attacks and/or disqualifying without sufficient evidence (at the sole and absolute discretion for the Moderator) any other party that may be accused of initiating such attacks or disturbances.

## 7. **DETERMINING THE WINNER**

- 7.1. The winning Hero Website shall be determined as follows:
  - 7.1.1. During the period between March 13, 2017 and March 15, 2017 (the "**Assessment Period**"), each day at 12:00 PM ET (noon), and 08:00 PM ET, Moderator will search the term "SEO HERO" via Google Search. Overall, there will be 6 events of search (the "**Search Events**").
  - 7.1.2. As for each Search Event, Moderator shall record the domain name of the HERO Website that will rank first on Google's organic Search (excluding local search results) out of all the Hero Websites participating in this Contest (who have not been disqualified) and such website shall be deemed to be the winner of the respective Search Event.
  - 7.1.3. The Hero Website that will win the highest number of Search Events shall be determined to be the winning Hero Website of the Contest and the Participant who owns such website shall be considered to be the winner of the Contest (subject to such Participant's compliance with the Rules) (the "**Winner**").
  - 7.1.4. In the event that upon the conclusion of the Assessment Period there will be a tie between several Hero Websites (the "**Final Websites**"), Moderator shall conduct an

additional Search Event, to take place on March 16, 2017, at 12:00 PM ET (noon), only in connection with the Final Websites. The website which shall rank first out of the Final Websites shall be determined to be the winning Hero Website.

- 7.2. Determination of Winner is final and binding subject to any further review as for compliance with the Rules.
- 7.3. The Contest shall have only one (1) Winner who will be awarded the prize set forth in Section 8 below (the "**Prize**").
- 7.4. Sponsor reserves the right to refrain from issuing the Prize if there are insufficient valid Entries that meet the criteria or comply with these Rules.

## 8. **PRIZE**

- 8.1. Sponsor will award the Winner the following Prize: \$50,000 (inclusive of any taxes imposed on such amount) (the "**Prize**").
- 8.2. The Prize (net of any deduction required to be made under applicable law) shall be transferred to the Winner as shall be decided by the Sponsor.
- 8.3. In the event Sponsor wins the Contest Sponsor shall donate 50% of the Prize (i.e. \$25,000) to a charity of its choice and the remaining amount shall be distributed equally between the Alternate Winners. The "Alternate Winners" shall be defined as the owners of such Hero Websites who ranked first, second and third place (excluding Sponsor) in the last Search Event performed by the Moderator. Each Alternate Winner shall receive \$8,333 (inclusive of any taxes imposed on such amount).
- 8.4. The Prize is non-transferable, with no equivalents or substitutions except at Sponsor's sole and absolute discretion and as detailed in Section 8.3. All Prize details not specified in these Rules, will be determined in Sponsor's sole and absolute discretion.
- 8.5. Sponsor reserves the right to substitute the Prize (or any portion thereof) with a prize of comparable or greater value in its sole and absolute discretion.
- 8.6. The Winner may further be required to provide Sponsor with additional details relating to the Entry, Winner's bank account details and other details as shall be reasonably requested by the Sponsor.
- 8.7. The Winner will be solely responsible for all federal, state and/or local taxes according to the laws and regulations applicable in Winner's residence, and for any other fees, costs and other arrangements associated with the Prize which are not explicitly provided by Sponsor as set forth herein. The Winner may be required to provide Sponsor with a valid social security number, tax identification number or any other identification details, before the Prize will be awarded for tax reporting purposes. An IRS Form 1099 or equivalent may be issued in the name of Winner for the actual value of the Prize received.
- 8.8. Without derogating from the generality of the above, any failure by the Winner to claim and collect the Prize, the failure of the Winner to execute any document requested by Sponsor or to otherwise cooperate with Sponsor as required, or for any other reason whatsoever at Sponsor's reasonable discretion, shall not result in any liability to the Sponsor. Under the aforementioned

circumstances, Sponsor reserves the right to refuse to provide the Prize to the said Winner and either forfeit the Prize or grant it to the runner-up contestant, at Sponsor's sole discretion.

- 8.9. Sponsor may conduct a background check to confirm any potential Winner's eligibility and compliance with these rules. By entering, you agree to cooperate reasonably with any such background check. If a background check reveals that a potential Winner has engaged in conduct that could damage the reputation or business of the Sponsor as determined by Sponsor in its discretion, or has violated the Rules, the potential winner may be disqualified and the Prize may be awarded to the runner up contestant.

## 9. **WINNER NOTIFICATION AND PRIZE CLAIMING**

- 9.1. Sponsor or Moderator will announce the Winner on or before March 30, 2017. The potential winner will be required to comply with all further instructions provided by Sponsor within the timeframe specified. Non-compliance within any indicated time period may result in disqualification and an alternate potential winner will be selected. Sponsor assumes no responsibility for undeliverable notifications for any reason whatsoever and the return of any notification as undeliverable will result in disqualification of the Entry and an alternate potential winner may be selected.
- 9.2. Sponsor has complete discretion over interpretation of the Rules and administration of the Contest, provided however that the Moderator shall have control over the any issue related to compliance with the Guidelines. In the event Mr. Hurvitz is prevented, by any reason, from acting as Moderator, Sponsor shall have the right to replace him, find an alternative mechanism for review of any Non-Compliance or refrain from further reviewing any Non-Compliance issues.
- 9.3. The potential Winner may be required to submit a notarized affidavit of eligibility / release of liability / prize acceptance agreement (the "**Prize Acceptance Agreement**"), and return same within the time period specified at notification before being eligible to receive his or her Prize. If the potential winner fails to timely submit a Prize Acceptance Agreement, their Entry may be disqualified at Sponsor's sole and absolute discretion and an alternate potential winner may be selected.

## 10. **PRIVACY AND CONTEST COMMUNICATIONS**

- 10.1. Except as specifically stated herein, your participation and the personal information collected from Participants during the Contest are subject to Sponsor's Privacy Policy and Terms of Use. You further undertake to comply with any and all applicable federal, state and local laws, rules and regulations.
- 10.2. By entering this Contest, you understand that Sponsor and each of its third party vendors, and its advertising or promotion agencies may use your personal information (including email address) for administration of the Contest and the fulfillment of the Prize. You expressly consent to the use of your information by Sponsor and each of its advertising or promotion agencies for such purposes.

## 11. **ENTRY LICENSE AND PUBLICITY RELEASE**

- 11.1. By submitting your Entry to the Contest, you acknowledge and agree that the Authorized Parties may use your name, username and your likeness, your Hero Website (or any part thereof) and

any element appearing in it, your Entry details and any other communications or comments related to the Contest (the “**Participants Material**”), as contemplated in Section 11.2 below.

- 11.2. By participating in the Contest, you grant Wix and each of its shareholders and licensees (“**Authorized Parties**”) an irrevocable, perpetual, worldwide non-exclusive, royalty-free license to use, display, edit, modify reproduce, distribute, broadcast, publish, perform and create derivative works of any part of the Participants Materials and otherwise use and exploit them, on their own or of any audiovisual or other production; all via the internet (including any social media platform) on any website (whether currently existing or as shall exist in the future), or any other interactive media, on television, in print and/or any other media currently existing and hereafter developed, without limitation and without payment of any compensation to you or your heirs and successors and without the need for any additional approval or consent from you; for the purposes of (i) advertising and promoting the Contest and/or any products or services of the Sponsor; and/or (ii) any other advertising, marketing, publicizing and promotional purposes and in any materials related thereto. The foregoing license is only in addition to and shall not derogate from any other license you grant Sponsor with respect to your Entry (such as the limited license granted under the Terms of Use).
- 11.3. Any display or publication of any Entry on an Authorized Party’s website or on any other channels and/or any other usage as aforesaid, does not indicate in any way that the Participant will be determined as a Winner or has better chances to be selected as a Winner and Authorized Parties will not be required to pay any additional consideration or seek any additional approval in connection with such use.
- 11.4. You hereby consent to Sponsor doing or omitting to do any act that would otherwise infringe your moral rights, privacy rights or publicity rights in your Entry and/or you Hero Website, or any materials featured therein, or in any other material produced in the framework of the Contest, or any of the Participant material, including but without limitation, the use of any Likeness, and to the fullest extent permitted by law you waive such rights.
- 11.5. Upon Sponsor’s request, each Participant must be prepared to provide (within seven (7) calendar days of receipt of Sponsor’s request) a signed license agreement authorizing the Authorized Parties to reproduce, distribute, display, and create derivative works of the Entry (or part thereof) and/or the Hero Website in connection with the Contest and promotion of the Contest, in any media now or hereafter known. All license agreements must be in the form provided by Sponsor or satisfactory to Sponsor. Failure to provide such license agreement upon request may result in disqualification at any time during the Contest and selection of an alternate potential winner.

## 12. **INTELLECTUAL PROPERTY**

The Contest Rules, the Contest, the Contest Page, the Hero Website created by Sponsor and all related web pages, content and code are the property of the Sponsor. The copying or use of any of those materials, associated trademarks or any other intellectual property without the express written consent of its owner is strictly prohibited.

## 13. **RELEASE**

- 13.1. By participating in the Contest, you agree to release in perpetuity, the Moderator, the Sponsor and their respective parent, subsidiaries, affiliates, agents, distributors, licensors, licensees, representatives, attorneys, Prize manufacturers and issuers, advertising and promotion agencies,



and each of their directors, officers, employees, agents, successors and assigns, as well as Facebook, Inc. (collectively – the “**Released Parties**”), from any claims, demands, liability, costs, losses, damages or injuries of any kind arising out of or related directly or indirectly to your participation in the Contest and your Hero Website, including, without limitation with respect to claims of copyright or trademark infringement, false endorsement, libel, slander, defamation or infringement of rights of publicity or privacy and any deletion or failure to store any Entries and other communications related to the Contest.

- 13.2. You agree that the Released Parties: (i) have neither made nor will be responsible for any warranty, express or implied, in connection with the Contest (including Prizes); (ii) will not be responsible or liable for any injury that may be caused by the wrongful act of any other person or entity, including Contest Participants, and by any cause whatsoever beyond the control of the Released Parties, and (iii) will not be responsible for lost, late, stolen, garbled, delayed, undelivered, or misdirected entries, for incorrect, inaccurate or incomplete entry information whether caused by a Participant, equipment, or technical malfunction or for any human error, technical error or malfunctions.
- 13.3. You agree that Released Parties are not responsible for any technical, computer, network, typographical, printing, human or other errors relating to or in connection with this Contest, including, without limitation, errors or problems which may occur in connection with the offer or administration of this Contest, the processing of Entries, the tabulation of scores, the cancellation of games or any errors appearing in any Contest related-materials including, but not limited, to errors in advertising, the Rules, the selection and announcement of the Winner or the distribution of the Prize.
- 13.4. Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries. The Released Parties are not responsible for any problems or technical malfunction of any telephone network, cable, satellite, wireless, Internet Service Provider (ISP) or lines, computer systems, servers, providers, computer equipment, software, malfunctions of wireless devices, wireless service problems, cellular tower equipment, failure of any email or entry to be received on account of technical problems or traffic congestion on the internet or at any website or wireless service congestion, or any combination thereof, including any injury or damage to Participant’s or any other person’s computer related to or resulting from participation or downloading any materials in this Contest.
- 13.5. You further understand and agree that all rights under Section 1542 of the Civil Code of California (“Section 1542”) and any similar law of any state, province or territory of the United States or of Canada that may be applicable are hereby expressly and forever waived. You acknowledge that Section 1542 provides that: “A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH, IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR.”
- 13.6. Upon Sponsor’s request, each Participant must be prepared to provide (within seven (7) calendar days of receipt of Sponsor’s request) a signed release or consent form from any person who appears, and/or owner of any property featured in the Entry displayed in the Entry or the Hero Website as requested by the Sponsor, and/or from the owner of any material that appears in such specific Entry or the Hero Website, authorizing Sponsor and its Authorized Parties use of such Entry as stipulated herein. All releases must be in the form provided by Sponsor or satisfactory

to Sponsor. Failure to provide such releases upon request may result in disqualification at any time during the Contest and selection of an alternate potential winner. For the avoidance of doubt, Sponsor's request to receive releases as aforesaid, or its failure to request the same, shall not (i) constitute a waiver of Sponsor's rights or your undertakings under the Rules or (ii) imply a representation or belief that your Entry complies with the Rules or any applicable Laws.

14. **YOUR REPRESENTATIONS, WARRANTIES AND INDEMNITY**

By submitting an Entry into the Contest you represent, warrant, undertake and agree that:

- 14.1. You have read, understand and will follow these Rules.
- 14.2. You have the right and the legal standing to agree to and be bound by these Rules and to register to the Contest.
- 14.3.
