**Charpentier, Emmanuelle (FRA), Director, Max Planck Institute for Infection Biology**

- In 2013, she was appointed Professor at the Helmholtz Centre for Infection Research in Braunschweig.
- She holds a position as research leader at the Laboratory for Molecular Infection Medicine Sweden (MIMS) as well as that of visiting professor at Umeå Centre for Microbial Research (UCMR)
- Charpentier will retain her position as visiting professor at Umeå University, where a new donation from the Kempe Foundations and the Knut and Alice Wallenberg Foundation has given her the opportunity to offer more young researchers positions within research groups of the MIMS(Molecular Infection Medicine Sweden) Laboratory
- Charpentier is best known for her role in deciphering the molecular mechanisms of the bacterial CRISPR-Cas9 immune system and repurposing it into a tool for genome editing.
- Among the approximately 15 researcher groups (at MIMS), one stands out in particular: the award winner of the Göran Gustafsson Prize 2014 in Molecular Biology Emmanuelle Charpentier's group, which has studied "Molecular mechanisms governing Gram-positive bacterial pathogenesis" and was the driving force behind the discovery of the mechanisms behind the CRISPR-Cas9 (mechanism by which DNA can be spliced with extreme ease and efficiency [likely to be the standard for all chimera projects]) system

- The Constitution requires that the king appoint, dismiss and swear in all government ministers and state secretaries.
- As king, he is also the president of the Council of State, an advisory body that reviews proposed legislation.

#### Noonan, Michael (IRL), Minister for Finance

Ratti (born 1971 in Turin, Italy) is an Italian architect, engineer, inventor, educator and activist founder of Carlo Ratti Associati and professor at the Massachusetts Institute of Technology where he directs the MIT Senseable City Lab, a research group that explores how new technologies are changing the way we understand, design and ultimately live in cities.
- In June 2007 the Italian Minister of Culture and Tourism Francesco Rutelli selected Ratti as a member of the Italian Design Council – an advisory board to the Italian government that includes 25 leaders of design in Italy.
- Since 2009 he has been a delegate to the World Economic Forum in Davos and is on the WEF Global Agenda Council for Infrastructure and Urban Development
  - Davos is host to the World Economic Forum (WEF), an annual meeting of global political and business elites (often referred to simply as Davos)

#### **Reisman, Heather M. (CAN), Chair and CEO, Indigo Books & Music Inc.**

- Indigo Books & Music Inc. ("Indigo") (TSX:IDG) is Canada's largest book, gift and specialty toy retailer, operating stores in all ten provinces and one territory and offering a robust selection of books, toys, home décor, stationery and gifts online at indigo.ca.
- Previously, she was president of Cott Corporation.
  - The Cott Corporation is a supplier of private label carbonated soft drinks distributing to Canada, the United States, Mexico, the United Kingdom, and Europe.
- She was backed by the Onex Corporation, one of Canada's largest and most successful conglomerates, and also controlled by her husband Gerry Schwartz,
  - Onex Corporation is a private equity investment firm and holding company based out of Toronto, Ontario. As of 2016, the firm has over \$22 billion of assets under management.
- Reisman has also served as a governor of the Toronto Stock Exchange.
- Toronto Stock Exchange (often abbreviated as TSX) is one of the largest exchanges in the world by market capitalization.
- Reisman is a member of the steering committee of the Bilderberg Group and participated in all its conferences since 2002.

#### **Rubin, Robert E. (USA), Co-Chair, Council on Foreign Relations**

- He served as the 70th United States Secretary of the Treasury (in control of the Exchange Stabilization Fund [a massive slush fund estimated to be in the Trillions]) during the Clinton administration.
- He spent 26 years at Goldman Sachs, eventually serving as a member of the board and co-chairman from 1990 to 1992.
- His most prominent post-government role was as director and senior counselor of Citigroup, where he performed ongoing advisory and representational roles for the firm.

- From November to December 2007, he served temporarily as chairman of Citigroup.
- He is currently engaged actively as a founder of The Hamilton Project. (See Roger Altman)
- He serves as chairman of the board of the Local Initiatives Support Corporation.
  - The Local Initiatives Support Corporation (LISC) is a US non-profit community development financial institution (CDFI) that supports community development corporations in 30 urban areas and dozens of rural areas in the United States. LISC was created in 1979 by executives from the Ford Foundation.
- He also serves as counselor at Centerview Partners, an investment banking advisory firm based in New York City.
- He directed the National Economic Council, which Bill Clinton created after winning the presidency.
  - The National Economic Council, or NEC, enabled the White House to coordinate closely the workings of the Cabinet departments and agencies on policies ranging from budget and tax to international trade and alleviating poverty. The NEC coordinated policy recommendations going into the President's office, and monitored implementation of the decisions that came out.
- In 1997 and 1998, Treasury Secretary Rubin, Deputy Secretary Lawrence Summers, and Federal Reserve Board Chairman Alan Greenspan worked with the International Monetary Fund and others to effectively combat and contain financial crises in Russian, Asian, and Latin American financial markets.
- Rubin and his deputy Lawrence Summers also steered through the 1999 repeal of the Glass–Steagall Act (1933), which had separated investment banking from the retail side. It allowed the banks to develop and sell the mortgage-backed instruments that became a principal factor in the financial collapse.
- In 2013, Rubin became a member of the Africa Progress Panel (APP), a group of ten distinguished individuals who advocate (Rob) at the highest levels for equitable and sustainable development in Africa (for Resources).
- He was a member of the U.S. Climate Risk Committee.
- In April 2016, he was one of eight former Treasury secretaries who called on the United Kingdom to remain a member of the European Union ahead of the June 2016 Referendum.
- Rubin has served on the board of directors of the New York Stock Exchange, the Ford Motor Company, Citigroup, the Harvard Corporation, the New York Futures Exchange, the New York City Partnership(The Partnership is comprised of business leaders representing the diverse sectors and interests in New York City), and the Center for National Policy(CNP is a think tank that currently has projects focused on the American workforce, democracy and development, innovation, resilience, and defense).
- He has also served on the board of trustees of the Carnegie Corporation of New York (\$3 Billion Endowment), Mt. Sinai Hospital and Medical School, the President's Advisory Committee for Trade Negotiations, the U.S. Securities and Exchange Commission Market Oversight and Financial Services Advisory

Committee, the Mayor of New York's Council of Economic Advisors and the Governor's Council on Fiscal and Economic Priorities for the State of New York.

- Rubin sharply opposed any regulation of collateralized debt obligations, credit default swaps and other so-called "derivative" financial instruments (Awful Crony Capitalist Policies).

#### Rutte, Mark (NLD), Prime Minister

- Rutte previously served as Undersecretary for Social Affairs and Employment from 22 July 2002 to 17 June 2004, and Undersecretary for Education, Culture and Science from 17 June 2004 until 27 June 2006, when he was elected to succeed Jozias van Aartsen as the new VVD Leader.
- After the 2003 elections Rutte was briefly also a member of the House of Representatives, from 30 January to 27 May 2003.
- Rutte resigned as Undersecretary in June 2006 to return to the House of Representatives, and he soon became the Parliamentary leader of the VVD. Rutte became an important figure within the VVD leadership. Rutte was campaign manager for the 2006 municipal elections.

#### Sawers, John (GBR), Chairman and Partner, Macro Advisory Partners

- He was Chief of the Secret Intelligence Service (MI6), a position he had held from November 2009 until November 2014.
- He was previously the British Permanent Representative to the United Nations from August 2007 to November 2009.
- Sawers joined the Foreign and Commonwealth Office in 1977. (See John Kerr)
- In his early career, Sawers worked in Yemen and Syria, on behalf of MI6.
- He became Political Officer in Damascus in 1982 and then returned to the Foreign & Commonwealth Office to take up the role of Desk Officer in the European Union Department in 1984 and Private Secretary to the Minister of State in 1986.
- He spent a year as an International Fellow at Harvard University and later at the British Embassy in Washington D. C., where he headed the Foreign and Defence Policy team.
- From January 1999 to summer 2001 he was Foreign Affairs Adviser to Prime Minister Tony Blair, dealing with all aspects of foreign and defense policy and working closely with international counterparts. (He reviewed the Iraq sanctions policy during this period and issued a document that included consideration of regime change. For three months was the British Government's Special Representative in Baghdad assisting in the establishment of the Coalition Provisional Authority as the transitional government during the Occupation of Iraq.)
- In August 2003, Sawers was appointed Director General for Political Affairs at the Foreign and Commonwealth Office. In this post he advised the Foreign Secretary on political and security issues worldwide and negotiated on behalf of the Foreign Secretary with international partners in the G8, EU and the UN.
- Already Knight Commander of the Order of St Michael and St George (KCMG), he was appointed Knight Grand Cross of the Order of St Michael and St George (GCMG) in the 2015 New Year Honours for services to national security.
- Sawers became Partner and Chairman of Macro Advisory Partners, who provide strategic advice and insights to investors and governments.

### Schäuble, Wolfgang (DEU), Minister of Finance

- He has served as Germany's Federal Minister of Finance in the second and third Merkel cabinets since 2009.
- From 1984 to 1991 he was a member of Helmut Kohl's cabinet, first as Federal Minister for Special Affairs and Chief of the Chancellery and then as Federal Minister of the Interior.
- Between 1991 and 2000, he was chairman of the CDU/CSU group in the parliament, and from 1998 to 2000 also CDU party chairman.
  - CDU/CSU, unofficially the Union parties Union, is the political alliance of the Christian Democratic Union of Germany (CDU) and Christian Social Union in Bavaria (CSU).
- He served again as Federal Minister of the Interior in the First Merkel cabinet from 2005 to 2009.
- Between 2007 and 2009, Schäuble was one of 32 members of the Second Commission on the modernization of the federal state, which had been established to reform the division of powers between federal and state authorities in Germany.
- By 2014, the Wall Street Journal called Schäuble "Germany's second most powerful person after Chancellor Angela Merkel.
- On 31 March 2014, Schäuble compared the annexation of the Sudetenland by Nazi Germany in 1938 to the annexation of Crimea by Russia in the 2014 Crimean crisis.
- He is Deputy Chairman of the Board of Supervisory Directors KfW, a lawfirm.
- He is a member of the Board of Trustees House of Finance, Goethe University Frankfurt.
- He is a Member of the Board of Trustees Max Planck Society. (See Charpentier, Emmanuelle)
- He is a Member of the Board of Directors of Robert Schuman Foundation.
  - The Robert Schuman Foundation is a Christian Democratic think tank.

### Schieder, Andreas (AUT), Chairman, Social Democratic Group

- Andreas Schieder is an Austrian politician and was from 2008 to 2013 the State Secretary in the Federal Ministry of Finance.

### Schmidt, Eric E. (USA), Executive Chairman, Alphabet Inc.

- Eric Emerson Schmidt is an American software engineer, businessperson, as well as the executive chairman of Alphabet Inc (formerly named Google)
- In 2016, Forbes ranked Schmidt as the 100th-richest person in the world, with an estimated wealth of \$10.8 billion.
- From 2001 to 2011, he served as the CEO of Google.
- On 20 January 2011, Google announced that Schmidt would step down as the CEO of Google but continue as the executive chairman of the company and act as an adviser to co-founders Page and Brin.
- On 28 August 2006, Schmidt was elected to Apple Inc.'s board of directors.
- On 3 August 2009, it was announced that Schmidt would resign from the board of directors at Apple due to conflicts of interest amid the growing competition between Google and Apple.



- Schmidt serves on the boards of the Institute for Advanced Study in Princeton, the Khan Academy, and The Economist.
- New America (See Ferguson, Jr., Roger W.) is a non-profit public-policy institute and think tank, founded in 1999. Schmidt succeeded founding chairman James Fallows in 2008.
- Founded in 2010 by Schmidt and Dror Berman, Innovation Endeavors is an early-stage venture capital.
- Schmidt was an informal advisor and major donor to Barack Obama's 2008 presidential campaign, he has since become a member of the United States President's Council of Advisors on Science and Technology (PCAST).
- Ash Carter appointed Schmidt as chairman of the DoD Innovation Advisory Board announced March 2, 2016. It will be modeled like the Defense Business Board and will facilitate the Pentagon at becoming more innovative and adaptive
- Schmidt has served on Google's government relations team.
- Schmidt has proposed that the easiest way to solve all of the domestic problems of the United States at once is by a stimulus program that rewards renewable energy and, over time, attempts to replace fossil fuels with renewable energy (green mafia).
- He is a member of the Bilderberg Group and attended the Bilderberg conference in 2011, 2012 and 2013.
- He also has a listed membership with the Trilateral Commission. (See James A. Johnson)

#### Scholten, Rudolf (AUT), CEO, Oesterreichische Kontrollbank AG

- Oesterreichische Kontrollbank AG (OeKB) is a special institution owned by the major commercial banks in Austria. It was founded in 1946. The OeKB is working among other things on behalf of the Republic of Austria .
  - OeKB acts as Austria's main financial and information services to the Republic of Austria, the export industry and the capital market.
- Scholten is president of the Bruno Kreisky Forum.
  - The Bruno Kreisky Forum for International Dialogue is a European think tank in Vienna . To this end, recognized politicians, opinion leaders and representatives from industry and academia from around the world are invited.
- He is a member of the steering committee of the Bilderberg group.
- He was Federal Minister for Science, Transport and the Arts (1996-1997).
- He was chairman of Acredia Versicherung AG, credit insurer.
- In 2006-2008, 2010-2011, and 2015-2016 He has participated in the Bilderberg Conference.

#### Schwab, Klaus (INT), Executive Chairman, World Economic Forum

- He is best known as the founder and executive chairman of the World Economic Forum. (See Halberstadt, Victor)
- His wife and former secretary, Hilde, co-founded the Schwab Foundation for Social Entrepreneurship with him.
  - The Schwab Foundation for Social Entrepreneurship provides platforms at the country, regional and global levels to promote social entrepreneurship.



- In 2004, Schwab created a new foundation using the US\$1 million prize money from the Dan David Prize he received that year from Israel. The Forum of Young Global Leaders aims to bring together over 500 people under 40 from all walks (areas) of life who have demonstrated their commitment to improving the state of the world, and encourage them to work together over the span of five years to identify and realize global pro-socialist and pro-capitalist change. (Indoctrination)
- From 1993-1995, Schwab was a member of the UN High-Level Advisory Board on Sustainable Development.
- From 1996-1998, he was Vice-Chairman of the UN Committee for Development Planning.
- He is a former member of the Steering Committee of the Bilderberg Group.

#### Sikorski, Radoslaw (POL), Senior Fellow, Harvard University; Former Minister of Foreign Affairs

- He was Marshal of the Sejm (Speaker of House) from 2014 to 2015.
- He was Minister of Foreign Affairs in Donald Tusk's cabinet between 2007 and 2014.
- He previously served as Deputy Minister of National Defense (1992) in Jan Olszewski's cabinet.
- He was Deputy Minister of Foreign Affairs (1998–2001) in Jerzy Buzek's cabinet.
- He was also Minister of National Defense (2005–2007) in Kazimierz Marcinkiewicz and Jarosław Kaczyński's cabinets.
- He studied Philosophy, Politics and Economics at Pembroke College, University of Oxford, where Zbigniew Pełczyński was one of his tutors.
- He helped launch the Polish bid to join NATO.
- Sikorski was the main architect, along with his Swedish counterpart and friend Carl Bildt, of the eastern policy of the EU – which came to be called the Eastern Partnership.
- In September 2015, after leaving the Foreign Ministry, Sikorski again visited Kiev, arguing that if Russia moves further into Ukraine, the West should provide it with defensive weapons. (location, location)
- On 6 November 2015 Sikorski was appointed a Senior Fellow at Harvard University's Center for European Studies. (Harvard is becoming a trend)

#### Simsek, Mehmet (TUR), Deputy Prime Minister

- Mehmet Şimşek (born 1 January 1967) is a Turkish politician and economist who currently serves as a Deputy Prime Minister of Turkey since 24 November 2015.
- He previously served as the Minister of Finance from 2009 to 2015, serving in the cabinets of Prime Ministers of Recep Tayyip Erdoğan and Ahmet Davutoğlu.
- He was elected as a Member of Parliament for Gaziantep in the 2007 general election and for Batman in the 2011 general election.
- Şimşek previously worked as the chief economist and strategist for emerging Europe, Middle East and Africa region at Merrill Lynch in London for 7 years.
  - Merrill Lynch Wealth Management is the wealth management division of Bank of America.
- He also served as senior economist and bank analyst for Deutsche-Bender Securities (a division of Deutsche Bank) from 1998 to 2000.

- Şimşek spent about a year in New York where he worked for UBS Securities in 1997. (See Kengeter, Carsten)
- Prior to that, he was a senior economist at the US Embassy in Ankara for almost four years.

**Sinn, Hans-Werner (DEU), Professor for Economics and Public Finance, Ludwig Maximilian University of Munich**

- Hans-Werner Sinn is a German economist and President of the Ifo Institute for Economic Research and serves on the German economy ministry's advisory council.
- In 2006 he became president of the International Institute of Public Finance, a position he held until 2009.
  - The International Institute of Public Finance, or IIPF, is a global organization of economists specializing in public finance.
- Since 1989 Sinn has served on the Advisory Council of the German Ministry of Economics.
- He represented the Free State of Bavaria on the Board of Supervisors of HypoVereinsbank for ten years.
  - UniCredit Bank better known under its brand name Hypovereinsbank (HVB), is the fifth-largest of the German financial institutions, ranked according to its total assets, and the fourth largest bank in Germany according to the number of its employees.
- He has been a member of the European Economic Advisory Group at CESifo (institute for economic research) (since 2001).
- He is also a research associate of the National Bureau of Economic Research (NBER).

**Skogen Lund, Kristin (NOR), Director General, The Confederation of Norwegian Enterprise**

- Major General Kristin Lund is the Force Commander of the United Nations Peacekeeping Force in Cyprus and a serving general in the Norwegian Army.
- She also served as Chief of Staff of the Norwegian Home Guard and as Deputy Commander of the Norwegian Army Forces Command.

  - The International Labour Organization (ILO) is a United Nations agency dealing with labour issues, particularly international labour standards, social protection, and work opportunities for all.

**Thiel, Peter A. (USA), President, Thiel Capital**

- Peter Andreas Thiel is a German-American entrepreneur, venture capitalist and hedge fund manager.

- Thiel co-founded PayPal with Max Levchin and Elon Musk and served as its CEO.
- He also co-founded Palantir, of which he is chairman.
  - Palantir Technologies, Inc. is a private American software and services company, specializing in big data analysis. Founded in 2004, Palantir's original clients were federal agencies of the United States Intelligence Community
- He was the first outside investor in Facebook, the popular social-networking site, with a 10.2% stake acquired in 2004 for \$500,000, and sits on the company's board of directors.
- Thiel serves as president of Clarium Capital, a global macro hedge fund with \$700 million in assets under management.
- He is a managing partner in Founders Fund, a venture capital fund with \$2 billion in assets under management.
- He is co-founder and investment committee chair of Mithril Capital Management.
- He is co-founder and chairman of Valar Ventures.
  - Valar Ventures has invested primarily in technology startups outside of the United States and has backed companies in countries spanning the globe, including Australia, New Zealand, Brazil, Canada, and the UK.
- He was ranked #4 on the Forbes Midas List of 2014 at \$2.2 billion.
- Thiel founded Palantir Technologies funded by the CIA's venture capital arm In-Q-Tel and serves as the company's chairman.
  - In-Q-Tel (IQT), formerly Peleus and known as In-Q-It, is an American not-for-profit venture capital firm based in Arlington, Virginia. It invests in high-tech companies for the sole purpose of keeping the Central Intelligence Agency, and other intelligence agencies, equipped with the latest in information technology in support of United States intelligence capability. (Military Industrial Complex 101)
- In March 2015, it was announced that Thiel joined Y Combinator as one of 10 part-time partners. (See Sam Altman)
- In December 2015 it was announced that Thiel is one of the financial backers of OpenAI (See Sam Altman)
- The Thiel Foundation supports the research of the SENS Research Foundation, headed by Dr. de Grey, that is working to achieve the reversal of biological aging.
- The Thiel Foundation also supports the work of anti-aging researcher Cynthia Kenyon.
- Thiel Stated, “Certainly, the area that I’m very passionate about is trying to do something to really get some progress on the anti-aging and longevity front,” describing it as ”a massively under-studied, under-invested phenomena.” (Elysium 101)
- In October 2011, the Thiel Foundation announced the creation of Breakout Labs, a grant-making program intended to fund early-stage scientific research that may be too radical or innovative for traditional scientific funding bodies but also too long-term and speculative for venture investors.
- Thiel is listed as a member of the Steering Committee of the Bilderberg Group.
- He participated in every conference between 2007 and 2016.

#### Tillich, Stanislaw (DEU), Minister-President of Saxony

- Dresden (Meeting Location) is the capital of the German state of Saxony.
- Since 2010, Tillich has been a member of the Christian Democratic Union's 20-strong executive board.

#### Vetterli, Martin (CHE), President, NSF

- Martin Vetterli is a professor (soon to be president) of engineering at the École Polytechnique Fédérale de Lausanne (EPFL) in Switzerland and the current president of the National Research Council of the Swiss National Science Foundation.

#### Wahlroos, Björn (FIN), Chairman, Sampo Group, Nordea Bank, UPM-Kymmene Corporation

- Björn Arne Christer Wahlroos (born October 10, 1952 in Helsinki) is the Chairman of the Board in Sampo Group, Nordea and UPM-Kymmene.

- She has advised both the former Chancellor Gerhard Schroeder and the current Chancellor Angela Merkel.
