Cougar Swim School is neither approved, carried out, nor supervised by the San Lorenzo Valley Unified School District and Kurt Edwards; (Contractor) is solely responsible for the Cougar Swim School programs.

In consideration of permission to use, today and on all future dates, the property, facilities of the San Lorenzo Valley Unified School District, Cougar Swim School staff, equipment and services of Cougar Swim Schools and Valley Sports Camp I, _____ for myself, my heirs, personal representative or assigns, do hereby release, waive, discharge, and covenant not to sue, Valley Sports Camp/Cougar Swim Schools, The San Lorenzo Valley Unified School District, all officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "related parties"), from liability from any and all claims including the negligence of related parties, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in activities, classes, observation, and use of facilities, premises or equipment.

Assumption of Risks: Physical activity, by its very nature carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries while using the San Lorenzo Valley High School property, facilities, and Cougar Swim School/Valley Sports Camp staff, and equipment. San Lorenzo Valley High School property Valley Sports Camp and Cougar Swim School have facilities for and provides for activities such as, but not limited to, hiking, running, swimming, spring board diving, water polo. I acknowledge that swimming, aquatic sports and other sports related activities are dangerous activities that may result in serious spinal injury or death even with careful supervision. I agree to release, indemnify, hold harmless Kurt Edwards of Cougar Swim School and Mark Mercer of Valley Sports Camp and their employees, agents, volunteers, & waive all claims, liability, (including attorney's fee) for property damage, bodily injury, & death arising from my/child's negligence or willful misconduct relating to me or my child's participation in the sports and swimming programs.
