Official Regulations and Guidelines

Eligibility Requirements

1. Feature length films/documentaries completed on or after March 15, 2012 are eligible, short documentaries completed on or after March 15, 2011 are eligible.
2. All entries must be either in English or subtitled in English.
3. Entrants confirm and warrant that they have the required legal authority to submit the entry into the festival and to use all music, images, and content in the entry.

Submission Guidelines

1. Films must be submitted on SDCard, USB Drive, DVD or Blu-Ray.
2. Only entries submitted with completed submission forms, entry fees, signed attestation forms, and films submitted in the requested formats will be considered.
3. This year (2014) the film committee is accepting only completed works; no works-in-progress will be considered.
4. The deadline for all submissions is March 14, 2014. Late entries will not be considered.

Submission of forms and films

1. Films may be submitted digitally through withoutabox, or shipped to the film committee.

4. The cost of shipping an entry to the Festival must be paid by the entrant. Collect or COD shipments will not be accepted.
5. Judging and Selection (Please see the website for information on rubrics for judging the various categories.) All entrants will be notified regarding inclusion in the Festival by March 17, 2014. The film selections will be posted on the website. A member of the Festival committee will also notify each entrant by phone or email.

Entry Fees

Each entry must be accompanied by the appropriate entry fee. Entry fees are not refundable. The fees may be paid by check, money order made payable to Trinity United Church of Christ, or by credit card (VISA, MasterCard, or American Express).
