DON'T UNC STUDENTS DESERVE THE SAME EQUAL RIGHTS AND EQUAL PROTECTIONS AFFORDED ALL CITIZENS? WHY DO UNC STUDENTS HAVE LESS RIGHTS THAN THE AVERAGE K-12 STUDENT? Chancellor Folt proudly implemented a new sex policy* where consensual sex at UNC-Chapel Hill may lead to your EXPULSION, your fate may be decided by a university employee and you will likely be branded a RAPIST

Under the new policy*, you can be charged with harassment or sexual misconduct if you:

- Upset another student by a verbal comment or one by email, text message or on social media (p.5)*
- Even if the comment was unintentional and not intended to harm (p. 6)*
- Or wasn't even directed at a specific target (p. 6)*
- And even if it only happened once (p. 6)*
- If you tease someone or make a joke that is "of a sexual nature" (p. 8)*
- If you look at another student and are aroused or gratified (p. 8)*
- If you walk in on your roommate while he/she is having sex (p. 8)*
- If you touch "another person's CLOTHED or unclothed body" (pg. 8)*
- If you "harass" a student's pet (p. 6)*

What happened to "No means no"?

CONSENT now means "an affirmative, conscious and freely-made decision to engage in agreed upon forms of Sexual Contact" (pg 9)*

If you CANNOT PROVE that you received a clear YES FOR EACH form of sexual activity you engaged in, you can be charged with SEXUAL ASSAULT for:


- Kissing
- Hugging
- Touching
- Any form of physical contact

Already dating someone?
"CONSENT is **not** to be inferred from an existing or previous dating or sexual relationship" (p. 9)*

*Policy on Prohibited Discrimination, Harassment, and Related Misconduct

- **In North Carolina, age K-12 students have more procedural DUE PROCESS rights than you do as a college student (§115C-390.8)**
- The University can remove or SUSPEND you without a hearing (p. 15)* or take "any other measure" it sees fit (p. 16)*
- Accused students (or their attorney) are NOT ALLOWED TO QUESTION THEIR ACCUSER; a student is NOT ALLOWED TO RECEIVE a copy of the *Investigation Report*" (p. 17**) – **Even K-12 students have these fundamental rights guaranteed them.**

**Procedures for Reporting and Responding to Complaints of Discrimination, Harassment, and Related Misconduct Involving a Student as the *Responding Party*

Thinking about having sex with another student? Consider:

- NEVER initiate any kind of sex activity if your partner is incapacitated!
- ALWAYS RECORD receiving affirmative consent PRIOR to the start of any sexual activity by making a video. Consider following these recommended steps:
 1. Turn the video on and have each person identify themselves by providing their names.
 2. Date stamp or state aloud what day and time the video is being made.
 3. Ask each person the following question: “Are you (*state the person’s name*) communicating your affirmative, conscious and freely-made decision to willingly engage in (*state the sexual activity you intend to engage in*) with me and agree to inform me to STOP at the point at which you wish to withdraw consent?” – Record his/her answer.
 4. Then ask, “Do you declare that you are of sound mind, that you were not threatened or coerced in any manner, and that you are not incapacitated by the influence of alcohol, drugs or medication?” – Record his/her answer.
