Humanities Center and Graduate Training: Data from the Anthropology Department

The Anthropology Department has long benefited from the training our graduate students receive at the Humanities Center. This training includes: 1) co-advising dual doctoral degrees between Anthropology and the Humanities Center; 2) Humanities Center faculty as external examiners for Anthropology doctoral defenses; 3) Anthropology graduate student enrollments in Humanities Center graduate seminars; and 4) co-taught courses with Humanities Center faculty and Anthropology faculty.

It is increasingly clear that interdisciplinarity is remaking the future of the humanities and social sciences. Faculty searches now clearly value candidates able to engage across disciplines over others who stay squarely within their disciplinary homes. Thus, the importance of the Humanities Center for our graduate training cannot be overstated. Our students consistently take Humanities Center courses throughout the first three years of their graduate training; several students seek out directed readings with Humanities Center faculty; and finally several students have had Humanities Center faculty as their external examiners for their dissertation defenses. The benefits of this deep collaboration between the Humanities Center and Anthropology is reflected both in our placement record and in our graduate student recruitment.

In the tables below, we summarize Anthropology graduate student enrollment in Humanities Center graduate courses between Fall 2010 to Spring 2016. The data is organized in two ways: 1) number of students enrolled in Humanities Center courses and number of courses enrolled in per academic year and 2) number of students who have enrolled in Humanities Center courses per cohort and percentage of cohort between entering years of Fall 2010 and Fall 2015.

Conclusions:

As can be seen from the data above, the norm is that 50 percent to 75 percent of our graduate students in each cohort take courses in the Humanities Center. Our placement record since 2007 demonstrates that highly successful placements have benefited from rigorous interdisciplinary training enabled by Humanities Center courses and mentoring.

In our recruitment process, prospective graduate students frequently express interest in the teaching and research of Humanities Center faculty. This interest is borne out in both student enrollments in Humanities Center courses and the service of Humanities Center faculty on Anthropology dissertation committees.

This data demonstrates the importance of the Humanities Center for the Anthropology Department's graduate training and shows that such collaborations between departments leads to strong outcomes in graduate student recruitment and placement.
