


Q1 What was your initial thought on Count 1 - Malice Murder



Q2 What was your initial thought on Count 2 - Felony Murder - Felony is count 4













Q8 If you had a strong feeling of guilty or not guilty prior to the trial starting have you modified your opinion since you have been able to view the trial and evidence?
















