COUNT 2

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JUSTIN ROSS HARRIS** with the offense of **DISSEMINATION OF HARMFUL MATERIALS TO MINORS, O.C.G.A. 16-12-103**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 29th day of May, 2014**, did knowingly disseminate and furnish to Mary Ashley Birmingham, a minor female under the age of eighteen (18) years, printed matter containing explicit and detailed verbal descriptions and narrative accounts of sexual excitement and sexual conduct, and which, taken as a whole, is harmful to minors, contrary to the laws of said State, the good order, peace and dignity thereof.

In this case of the State of Georgia vs. JUSTIN ROSS HARRIS, the State, through the Office of the District Attorney, requests a Bench Warrant issue for the defendant based upon the return of an indictment by the Grand Jury. Based upon the facts and circumstances, the State recommends a \$ NO bond to be set in this case.
