**Juried Small Works Art Show - SUBMISSION DEADLINE: October 1, 2017**

**Exhibit Dates: November 1, 2017 – January 5, 2018**

**Artists' Reception: November 12, 2017, 2pm-5pm**

*Does size matter? How does size limitation impact your artistic style and expression? Artists are asked to recalibrate their individuality and explore new possibilities through their small works.*

**VOLITION GALLERY** is located in the historic Bell-ans Center of Creative Arts in Orangeburg, New York.

**ELIGIBILITY:** Open to all artists age 18 and over in New York, New Jersey and Connecticut.

Painting, drawing, photography, collage, printmaking and sculpture are all welcome. Artwork must not exceed 12” x 12” (or 144” sq. inches), including frame or base. Sculpture limited to 25 lbs. Work must have been completed within the past two years and not previously shown at the Volition Gallery. If applicable, artwork must be framed and ready to hang.

**ENTRY FEE:** \$30 for first 3 entries, \$5.00 for each additional entry (maximum 5 entries total, fee non-refundable)

**SUBMISSION:** Deadline: October 1, 2017. Mail photos or disks with SASE and check or Email jpegs (72ppi or max file size 2mb) to [surrendertosmall@outlook.com](mailto:surrendertosmall@outlook.com). Selected artists will be notified via e-mail on or about October 10, 2017.
