

# Ticks and tick-borne illnesses spreading

**Q. My neighbor's dog was recently diagnosed with Lyme disease. I am confused what type of tick causes it and what I should be doing to avoid this happening in my pets?**

You are not alone in your confusion. Tick populations and the incidence of tick-borne diseases are spreading. Climate change has led to longer tick seasons.

Ticks are not just a backyard problem, but have become a backyard problem as well. The diseases they carry are not only affecting pets but people as well. You want

to protect your pet against Lyme disease as well as Rocky Mountain spotted fever, Babesiosis, Anaplasmosis and Ehrlichiosis.

Different ticks carry different infectious diseases, and not all treatments manage all tick problems. Your veterinarian should advise you on the best products for your situation and the proper use of tick repellents and acaricides.

There are many products available — collars, sprays and spot-on products. Some of these are available over the counter, but serious problems may occur when they are used improperly. Please consult your veterinarian before beginning any treatments.

The best way to find ticks on your pet is to run your hands over the whole body. Check for ticks every time your pet comes back from an area you know is inhabited by ticks. Ticks attach most frequently around the pet's head, ears, neck, and feet, but are by no means restricted to those areas.

Luigi and is bringing in at least 20 more dogs today.

The foster families pay no money out-of-pocket. They are given all the needed dog supplies and rescue groups pay veterinarian bills, as well. A foster family just needs to provide time and love. And while puppies often require someone home all day, older dogs can easily — and happily — fit into a family that works and goes to school.

"An older dog that would've [otherwise] been dead, having to sit on a couch for eight hours? That's not too bad," says Urman. "I'm realistic about this. If you don't work, they don't eat."

Urman must be pragmatic. She deals in numbers of dogs saved, homes found, fosters available. But there is another side to fostering that has nothing to do with practicality. It is about the personal benefits of doing good and bonding with the needy animals.

"It's very rewarding, because you get to save lives," Cecchetti says of fostering.

Often families get attached to their dogs. Some end up keeping them. Others cry and reluctantly let go, trying to focus on the happy ending.

The Kraykowski family of Dumont has fostered about 16 dogs over the last year. Mother and

## Before you foster a dog

*Sandy Kraykowski has brought at least 16 foster dogs into her Dumont home over the last year. Here are her suggestions for people thinking about fostering a dog.*

- Be prepared to have a foster dog for an average of one to five weeks for a puppy, one to four months for an older dog.
- Be patient and understanding. Most of these dogs are scared and are going to be difficult for the first 24 to 48 hours. They may bark, cry, whine, chew or have an accident.
- Be willing to go slow, especially with kids (don't wake up the dog, don't bother while it's eating, etc.).
- Give the dog space to explore

and adapt to the new surroundings.

■ Be ready to meet and assess prospective adoptive families.

■ Allow 24 to 48 hours for the rescue organization to find another home if there is an issue and the dog can't stay until it's adopted.

The bond ordinance, the summary terms of which are included herein, has been finally adopted by the Borough Council of the Borough of Glen Rock, in the County of Bergen, State of New Jersey on March 14, 2012 and the 20-day period of limitation within which a suit, action or proceeding questioning the validity of such ordinance can be commenced, as provided in the Local Bond Law, has begun to run from the date of the first publication of this statement. Title: BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT, NEW INFORMATION TECHNOLOGY EQUIPMENT AND A NEW AUTOMOTIVE VEHICLE, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE BOROUGH OF GLEN ROCK, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$1,210,800 TO PAY THE COST THEREOF, TO APPROPRIATE A COUNTY GRANT, TO MAKE A DOWN PAYMENT OR FULLY OR PARTIALLY FUND APPROPRIATIONS FROM THE CAPITAL IMPROVEMENT FUND, TO APPROPRIATE CAPITAL SURPLUS, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

ment. Nespresso machines (\$150 to \$400) and Keurigs (\$100 to \$190) have their own fervent followers who will never go back to their old ways after brewing and steaming for the perfect homemade latte. Starbucks will introduce the Verismo espresso machine later this year, which Small says can be a game-changer because of the company's gigantic retail footprint.

Nespresso owners don't have it easy. The coffee can be purchased only online or at a Nespresso boutique store, the nearest of which is in Manhattan. The aluminum coffee capsules cost about 55 cents each and must be ordered in packs of 50. They are color-coded by coffee strength and style. Keurig owners, however, can find their K-Cups just about anywhere and have more choices than ever before.

"There has definitely been an explosion in options," says McAleavy.

There are 25 brands and more than 200 varieties of coffee, tea, hot chocolate and other hot bev-

## Keep your K-Cup costs down

People love the convenience but not the cost of the coffee for Keurig single-serve machines. On Keurig's website, prices range from about 62 cents per cup for Green Mountain Breakfast Blend to about 83 cents per cup for Starbucks Breakfast Blend. Here are a few ways to save on K-Cup purchases.

- Buy a reusable filter that can be filled with your own coffee. Not as convenient but it also helps Mother Earth. The Ekobrew Cup is available online for \$11.
- Buy K-Cups in bulk from

Amazon.com or stores like Costco and BJ's. There isn't as much variety but the savings will make the fewer choices more tolerable; at Costco, the coffee costs an average of 53 cents per cup compared to an average of 73 cents per cup if purchased from Keurig's website.

■ Wait till fall. Green Mountain is losing a couple of key patents in September and when those expire, so too will the royalty payments other companies have to pay to make K-Cups. So prices will go down and options should increase. — **Kara Yorio**

erages available for the K-Cup.

And now Keurig has a new system, the Vue, which offers more options for size of cup and strength of coffee. The V-Cups can be recycled in places that take No. 5 plastic, eliminating one of the biggest knocks on K-Cups — that they are not green. (Nespresso's aluminum coffee pods are recyclable.)

"I do care about the environ-

ment," says McAleavy. "But when you look at what's still manufactured and still out there, I think that's less egregious than buying Styrofoam and throwing it out or throwing pots away all the time. If they come up with a recyclable plastic to use, that would be great."

The Keurig website says the company is working on that.
