

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

Vashon Birds and Bees Beekeeping Essentials Class

1. In consideration taking beekeeping instruction and / or engaging in an activity around honeybees at 20602 111th Ave SW, Vashon WA 98070 (training premises), I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Birds and Bees Vashon, David J. Skrzypek, Karen Biondo, their families, officers, agents, servants, or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death that may be sustained by me or any of the property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES or otherwise while participating in such activity, or while in, on or upon the premises where the activity is being conducted.
2. I am fully aware of the unusual risks involved and hazards connected with all activities involving honeybees including but not limited to handling, observing, approaching hives, and manipulation of hives while working with bees. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
3. I understand I am participating at my own risk and in FULL knowledge that there is an element of risk that an accident could occur and result in injury or death to the participant. I also understand that while participating in this class, it is highly recommended and requested by RELEASEES to wear clothing that reduces risk of aggravation to honeybees, such as avoiding dark wool, fur, dark fleece or fleece-textured clothing.
4. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
5. This Waiver of Liability and Hold Harmless-Agreement shall bind the members of my family and spouse, if I am-alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Washington.
6. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
7. DISCLAIMER-I hereby release RELEASEES from all liability for any injury, Damage, or insult (real or imagined) in connection with my activities at this facility.
