Liability Bond and Extent of Liability. We, of SUPERIOR COURT OF CALIFORNIA COUNTY OF SAN FRANCISCO, CALIFORNIA STATE DISBURSEMENT UNIT and ALISHA ANNE GRIFFIN (Debtors), are held firmly bound unto Shana Misako, Okuda, (Secured Party), in the sum of present Collateral Values and any claims and debts and losses claimed by any and all persons against Debtors and/or the Commercial Transaction investments and activities of the Collateral up to the penal sum of Four-million and no/100 dollars (\$4,000,000.00) shall mean that Debtors' liability shall be limited in Collateral to gold and/or silver of the united States of America for the payment of which well and truly be made we bind ourselves and our heirs and executors' administrators and third party assigns jointly and severally and firmly by these presents.

The condition of the above bond (whereas certain Collateral is utilized for the purpose of conducting commercial activity by the Debtors) are in pursuance of the Statutes in such case made and provided indentured to the Secured Party; by which indenture Secured Party covenanted to do certain things as stated in Agreement.
