SPECIFICATIONS

Entry form and Artist BIO must be emailed to info@museumofspecialart.org concurrent with four digital photos of artwork to be reviewed along with a photo of the artist for the BIO. Artist is limited to two pieces per entry unless otherwise notified. Artist will be notified by email if their work has been selected for the MOSA "Colors of my World" Exhibition.

Photographs, Drawings, and Watercolor Paintings must be matted and framed under glass. Acrylics/Oils framed if possible or at minimum, artist must finish and paint edges of canvas for presentation. Framing materials touching artwork must all be "Acid Free" materials. "Do not" use cardboard or plastic on any part of your framing materials.

TABLE DISPLAY RESERVATIONS:

(For those who reserve display tables on opening day)

All artwork on table displays must have a professional presentation and may include small gift items as prints, cards, mugs, and jewelry or small glass gifts. Display Table reservations are on a first come first serve basis.

Items for sale on TABLE DISPLAYS

Artwork being sold on the table displays must be accompanied with Price Tags either in paper or added to items with self-adhesive stickers. An inventory price list must also be provided to the cashier at the opening reception.

DEADLINE FOR SHOW ENTRY is October 22, 2016.

ENTRY FEE: The entry fee is \$40.00 per artist and is to be paid by check to the Museum of Special Art.

Display Table Reservations: is an additional \$25.00 per each 6ft table.

All artwork must be received at the MOSA Museum on **Saturday, October 29th between 1-4pm**. All Artwork being submitted must be accompanied with the \$40.00 Entry FEE, Entry Form, Artist BIO, and with an ***Artwork ID Tag** attached to the back of each piece of artwork being submitted. *(see page 3 for Artwork ID Tag form.)

No entry may be withdrawn from the MOSA exhibition before its conclusion on Friday March 24, 2017 at 4pm. All Artwork may be picked up at the MOSA Museum on Saturday, March 25, 2017 between 1-4pm. (Pick up dates/times are subject to change). If all Artwork is not picked up on Saturday March 25th at the MOSA Museum between 2-4pm, then the unclaimed work will become the property of the Museum of Special Art with the exception of any International artwork or domestic artwork located outside of WA State which will be mailed back to the artist.

SALES

All artwork exhibited, must include an art ID TAG that clearly identifies the title, medium and sales price. If you do not want to sell the work, check "Not For Sale" on the Artwork ID Tag (pg. 3). Artwork for sale will be sold through the MOSA Museum. The MOSA Museum will receive a 30% commission for the sale of each piece of artwork. The remaining funds received from the sale of the work will be mailed to the artist by the MOSA Museum with an enclosed check to the address the artist has listed on the submission entry form. During the opening reception, each Artist is responsible to keep track of their inventory of sold items. No Artwork displayed for sale hung on exterior gallery walls or entry may be withdrawn from the "Colors of my World" exhibition before its conclusion on **Friday, March 24, 2017 at 4pm**.

REPRODUCTION

Any artwork accepted for this show may be reproduced for publicity and submission constitutes permission for this purpose.

LIABILITY

All works are entered at artist's own risk. All reasonable care in handling and exhibiting art works will be taken. The exhibitor agrees to hold harmless the Museum of Special Art, its officers, employees or agents for any loss or damage of any artwork submitted or selected for exhibition. The MOSA Museum does not carry any insurance for artwork.
