## The Star Project Contest Official Rules January 24, 2014 – March 17, 2014

**PRELIMINARY INFORMATION:** NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Star Project Contest ("Contest") will begin on January 24, 2014 at 9:00 AM ET and end on March 17, 2014 at 11:59 PM ET ("Contest Period"). All times in the Contest refer to Eastern Time ("ET"). Odds of winning depend upon the number of eligible Entries (defined below) received. Contest is subject to all applicable federal, state and local laws.

ELIGIBILITY: Open only to permanent, legal United States ("U.S.") residents who are physically residing in one (1) of the fifty (50) U.S. or the District of Columbia (excluding Puerto Rico, Guam, the U.S. Virgin Islands and other U.S. territories), and who are eighteen (18) years of age or older as of the start of the Contest Period and of African, Latino, Asian or Native American descent. Entrants must have a valid U.S. Social Security Number or a valid U.S. personal tax identification number. Officers, directors, and employees of Contest Entities (as defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Contest. Contest Entities, as referenced herein, shall include NBCUniversal Media, LLC, 100 Universal City Plaza, Bldg. 1320, Suite 1D, Universal City, CA 91608 ("Sponsor"), American Black Film Festival c/o Film Life, Inc. ("ABFF"), and their respective parent, subsidiary, and affiliate companies, and administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, promotion, or implementation of the Contest. Entrants must be available to travel to New York, New York, June 19, 2014 through June 23, 2014, and Grand Prize Winners (defined below) must be available to travel to Los Angeles, California, June 23, 2014 through December 31, 2014. Travel to audition is not included, except as specifically provided below. Entries must comply with all applicable laws, rules, and regulations. Entrants must also be of good moral character. Sponsor reserves the right to exclude anyone convicted of a crime (other than moving violations of a misdemeanor type that did not involve personal injury, drugs, or alcohol). Entrants must have nothing in their background that would be an embarrassment to Sponsor, and entrants may not be elected officials or currently running for any political office (local, state or federal). At Sponsor's request, each entrant must be willing to sign a publicity release and an affidavit attesting that such entrant meets all of the foregoing eligibility requirements outlined above. Sponsor reserves the right to disqualify entrants for not meeting any of the requirements outlined above or for any other reason, in Sponsor's sole discretion.

**HOW TO ENTER:** To enter the Contest, during the Contest Period log on to www.ABFF.com (the "Website"), click on TALENT DISCOVERY and then click on STAR PROJECT to access the online submission form (the "Submission Form"). Complete the Submission Form according to the provided instructions.

In addition to the Submission Form, you will also be required to submit: (1) your acting resume ("Resume"); and (2) a video ("Video") of two (2) monologues performed by you (each a

"Monologue"). You must include the Video as a private online link (for example, an unlisted YouTube video, a password protected Vimeo, etc.) ("Video Link"). DO NOT SUBMIT A HARD COPY. The first Monologue must be a two (2) to three (3) minute Monologue of entrant's choice ("Monologue 1"). The second Monologue must be one (1) of the monologues provided on the Website ("Monologue 2").

You must email your Submission Form, Resume, and Video Link (collectively, the "Entry") to: <u>diversity@nbcuni.com</u> with the subject line: "THE 2014 STAR PROJECT" AND YOUR FULL NAME. Your Entry must include your two (2) Monologues. Entries must be received by March 17, 2014 to be eligible for the Contest. All Entries become the property of Sponsor and will not be acknowledged or returned.

You must submit Monologue 1 and Monologue 2 as described above as part of your Entry to enter and be eligible for Contest. Only you should appear in Monologues. The Monologues must have been recorded within Contest Period and must be in color. Monologues cannot have been previously submitted in a contest of any kind or exhibited or previously displayed publicly through any means.

By entering the Contest, entrants grant Sweepstakes Entities the non-exclusive, royalty-free, and irrevocable rights to use, reproduce, copy, publish, display, distribute, perform, translate, adapt, modify, and otherwise exploit your Monologues and to incorporate Monologues in other works in any and all markets and media worldwide in perpetuity. If Contest Entities, in their sole discretion, elect to incorporate any Monologue into other works, the use of such Monologue will not be considered an employment opportunity and contestant will not be entitled to any compensation or credit. Contest Entities expressly reserve the right to post on the Website selected and/or edited versions, in their sole discretion, of Monologues submitted. Entrants will have no right of review, notice, or approval of the content in Monologues posted on the Website. Entrants warrant that they have the sole and exclusive right to grant such rights to Contest Entities and that the Contest Entities' reproduction, publishing, displaying, and/or other use of Monologues will not infringe on any rights of third parties, including, without limitation, copyright, trademark, privacy, or publicity rights, or create claims for defamation, false light, idea misappropriation, intentional or negligent infliction of emotional distress, or breach of contract. If any Monologues contain material that is violent, pornographic, obscene, illegal, inappropriate, or racially or morally offensive or if any Monologues do not comply with these Official Rules or meet Sponsor's standards for any reason, as determined by Sponsor in its sole discretion, such Monologues (and the related Entries) may be rejected as ineligible for consideration. Entries must comply with all applicable laws, rules, and regulations. Contest Entities shall have no obligation to copy, publish, display, or otherwise exploit the Monologues.

Entries must be received by March 17, 2014 to be eligible for the Contest. Sponsor's computer shall be the official timekeeper for all matters related to this Contest. You may enter once during the Contest Period. Multiple Entries received from any person or email address beyond this limit will void all such additional Entries. Entries generated by a script, macro, or other automated means will be disqualified. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant,

the authorized account holder of the email address used to enter will be deemed to be the entrant. "Authorized account holder" is defined as the person who is assigned to an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. Entry constitutes permission (except where prohibited by law) to use entrant's name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval.

**PRIVACY:** Information provided by entrants is subject to Sponsor's privacy policy located at <u>http://www.nbcuni.com/privacy/</u>.

**SELECTION AND NOTIFICATION OF FIRST ROUND FINALISTS, SECOND ROUND FINALISTS AND GRAND PRIZE WINNERS:** There will be three (3) rounds of judging: Round 1: Initial Judging to Determine First Round Finalists; Round 2: Public Voting and Finalist Auditions; and Round 3: Final Judging to Determine Grand Prize Winners.

**Round 1: Initial Judging to Determine First Round Finalists:** On or about April 9, 2014, a panel of qualified judges selected by Sponsor ("Initial Judges") will review the eligible Entries received during the Contest Period on a rolling basis and will select three (3) potential male first round finalists and three (3) potential female first round finalists ("each a First Round Finalist"), for a total of six (6) potential First Round Finalists based on the following initial judging criteria ("Initial Judging Criteria"): Talent (50%) and Delivery (50%). In the event of a tie, the Initial Judges for Delivery to advance to Round 2: Public Voting and Finalist Auditions. In the event a tie remains, an additional tie-breaking judge will judge the tied Entries using the Initial Judging Criteria, to determine which of the tied entrants will be the potential First Round Finalist. Sponsor reserves the right to pick fewer than six (6) First Round Finalists (or none at all) or to extend the Contest Entry Period if the Contest does not receive a sufficient number of eligible and qualified Entries, as determined by Sponsor in its sole discretion. Decisions of Sponsor and Initial Judges are final and binding with respect to all matters related to the Contest. Winning is subject to verification of eligibility.

**Round 2: Public Voting and Finalist Auditions:** On or about May 1, 2014, following Round 1: Initial Judging to Determine First Round Finalists, each First Round Finalist's Monologue 2 will be posted on the Website in a randomized manner for public viewing and voting. On or about May 1, 2014 at 12:01 AM ET until June 20, 2014 at 11:59 PM ET, or on such other dates and at such other times as determined by Sponsor in its sole discretion (the "Public Voting Period"), visitors to the Website may vote for his or her favorite First Round Finalist according to the Initial Judging Criteria, voting rules, and procedures established by Sponsor, which will be posted on the Website. The Public Voting Period, voting rules and procedures and voting methods are subject to change, at the Sponsor's sole discretion, and any changes will be posted on the Website. Voting is currently limited to one (1) vote per person per day during the Public Voting Period, but Sponsor reserves the right to change the limit on the number of votes, in their sole discretion. Notification regarding any such change will be announced on the Website.

Additionally, all six (6) First Round Finalists will be invited to attend the 2014 ABFF, scheduled to occur from June 19, 2014 to June, 23, 2014 in New York, New York (the "Festival") for a live on-site audition for an NBC talent executive and/or other qualified judges (each a "Finalist Audition"). Sponsor will provide round trip, coach class airfare for each First Round Finalist from a major airport near First Round Finalist's residence to a major airport in or near New York, New York ("Finalist Audition Travel Expense") and credentials for each First Round Finalist to attend the Festival. Finalist Audition Travel Expense consists only of airfare as specified above. First Round Finalists are responsible for their own lodging and ground transportation in New York, New York. NO ACCOMMODATIONS PROVIDED. All details of Finalist Auditions and Finalist Audition Travel Expense will be determined by Sponsor in its sole discretion. First Round Finalists must be able to travel June 19, 2014 through June 23, 2014 (or on such other dates designated by Sponsor). Finalist Audition must be completed on the date specified by Sponsor or First Round Finalist may be disqualified and, at Sponsor's sole discretion, an alternate First Round Finalist may be selected from the remaining eligible Entries. Sponsor has the right in its sole discretion to substitute ground transportation for air transportation depending on First Round Finalist's place of residence.

Round 3: Final Judging to Determine Grand Prize Winners: On or about June 22, 2014, following the Public Voting Period and Finalist Auditions, one (1) or more qualified judges selected by Sponsor ("Final Judges") will select one (1) male and one (1) female grand prize winner (each a "Grand Prize Winner"), for a total of two (2) potential Grand Prize Winners, based on the following judging criteria ("Final Judging Criteria"): Scores from Initial Judges (40%), Results from Public Voting Period (20%), and Scores from Finalist Auditions (40%). In the event a tie remains, an additional tie-breaking judge will judge the tied Entries, using the Initial Judging Criteria, to determine which of the tied Entries will be the Grand Prize Winner, subject to verification of eligibility. All First Round Finalists will attend the ABFF Awards Ceremony (the "Ceremony"), scheduled to take place in New York, New York on June 22, 2014 at 9:30 PM ET. Grand Prize Winners will be announced at the Ceremony. Grand Prize Winner will be required as a condition of continued eligibility to sign an Affidavit of Eligibility, Waiver of Liability, and, except where prohibited, Publicity Release (collectively, "Contest Documents") within two (2) days of such notification. Noncompliance within this time period will result in disqualification. If the potential Grand Prize Winner cannot be reached or if it is found ineligible, if it cannot or does not comply with the foregoing requirements and these Official Rules, if its prize or prize notification is returned as undeliverable, or if it does not satisfactorily execute all of the Contest Documents, potential Grand Prize Winner will be disqualified and Sponsor will award the Grand Prize (defined below) to the runner-up First Round Finalist.

**GRAND PRIZE:** There will be two (2) grand prizes (each a "Grand Prize") awarded; one (1) Grand Prize will be awarded to each Grand Prize Winner. Each Grand Prize consists of an opportunity for Grand Prize Winner to audition with a leading casting director chosen by ABFF and NBCUniversal Casting in their sole discretion ("Casting Director") in Los Angeles, California by December 2014 (the "Los Angeles Audition"). Depending on Grand Prize Winner's place of residence, as determined by Sponsor in its sole discretion, Sponsor will be responsible for travel and accommodations ("Trip") for Los Angeles Audition. Trip includes: round trip, coach class airfare for Grand Prize Winner from a major airport near Grand Prize

Winner's residence to a major airport in or near Los Angeles, California ("Destination Airport"), two (2) nights of hotel accommodations for Grand Prize Winner at a hotel in or near Los Angeles, California, as determined by Sponsor in its sole discretion ("Hotel"), roundtrip ground transportation between Destination Airport and Hotel, and roundtrip ground transportation between Hotel and Los Angeles Audition. Subject to Sponsor's sole discretion, one (1) Grand Prize Winner could have the opportunity to appear as an extra ("Walk-On Role") on an NBCUniversal television series (the "Series") at a date and location to be determined by Sponsor in its sole discretion. IF GRAND PRIZE WINNER RESIDES IN LOS ANGELES, CALIFORNIA, NO TRIP OR ANY TRANSPORTATION OR ACCOMMODATIONS OF ANY KIND WILL BE PROVIDED TO GRAND PRIZE WINNER, AND NO ADDITIONAL COMPENSATION WILL BE AWARDED TO GRAND PRIZE WINNER. Grand Prize Winner must be able to travel June 23, 2014 through December 31, 2014 (or on such other dates designated by Sponsor). Los Angeles Audition must take place on such date designated by Sponsor or Los Angeles Audition will be forfeited. The Trip awarded to the Grand Prize Winner must be taken within dates provided by the Sponsors or the Grand Prize will be forfeited. If Grand Prize Winner is chosen for the Walk-On Role, Walk-On Role must take place on such dates designated by Sponsor or Walk-On Role will be forfeited.

The Estimated Retail Value ("ERV") of each Grand Prize is one thousand dollars (\$1,000). The ERV of all Grand Prizes is two thousand dollars (\$2,000). Actual Retail Value ("ARV") of Grand Prize may vary based on points of departure, travel dates and residence of Grand Prize Winner. Any difference between ERV and ARV will not be awarded. Sponsor will furnish an Internal Revenue Service Form 1099 to Grand Prize Winners for the ARV of Grand Prize for the year in which Grand Prize was won.

All details of Grand Prize will be determined by Sponsor in its sole discretion. Sponsor reserves the right to substitute a similar Grand Prize (or Grand Prize element) of comparable or greater value. If a Grand Prize element is not available for any reason, as determined by Sponsor in its sole discretion, the remaining elements of Grand Prize shall be awarded and shall constitute full satisfaction of Sponsor's Grand Prize obligation to Grand Prize Winner and no additional compensation or substitution will be awarded. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of Grand Prize are the sole responsibility of Grand Prize Winner. Grand Prize cannot be transferred by Grand Prize Winner or redeemed for cash and is valid only for the items detailed above, with no substitution of Grand Prize by Grand Prize Winner. If Grand Prize is unclaimed within a reasonable time after notification from Sponsor, as determined by Sponsor in its sole discretion, it will be forfeited, and time permitting, an alternate Grand Prize Winner may be selected from the remaining eligible Entries at Sponsor's sole discretion.

The location and all details of the Los Angeles Audition will be determined by the Casting Director and Sponsor in their sole and exclusive discretion. The location and all details of the Walk-On Role will be determined by the Series producers ("Producers") and Sponsor in their sole and exclusive discretion. Los Angeles Audition and Walk-On Role will be subject to availability and production exigencies. Date and/or time of Los Angeles Audition and Walk-On Role are subject to change. Los Angeles Audition and Walk-On Role are subject to cancellation. Grand Prize Winner must be available for Los Angeles Audition during Casting Director's

schedule, specifically, on the dates selected by Casting Director and Sponsor. Grand Prize Winner must sign and agree to all the terms and conditions of Casting Director's agreement, if any, and/or other agreements from Sponsor pertaining to the Los Angeles Audition and follow all instructions given by the Casting Director and Sponsor. If chosen for the Walk-On Role, Grand Prize Winner must be available during the Series' production schedule, specifically, on the dates selected by Producers and Sponsor, must sign and agree to all the terms and conditions of Producer's "Walk-On" agreement and/or other agreements from Sponsor pertaining to the Walk-On Role before traveling to the set, and must follow all instructions given by the Producers and Sponsor. In the event that the Los Angeles Audition and/or Walk-On Role do not or cannot take place as scheduled or at all, for any reason including but not limited to scheduling conflicts, cancellations, postponement, an event of force majeure, or for any other reason, then the remaining components, if any, of the Grand Prize shall constitute full satisfaction of Sponsor's Grand Prize obligation to Grand Prize Winner, and no other or additional compensation will be awarded.

Grand Prize Winner is solely responsible for all expenses and costs associated with acceptance and/or use of Grand Prize not specifically stated herein as being awarded, including, without limitation any and all taxes and other expenses, costs, or fees associated with the acceptance and/or use of Grand Prize, travel insurance, ground transportation (other than as described above), security and airport fees, taxes, insurance, gasoline, meals, gratuities, and souvenirs. Sponsors shall have the right, but not the obligation, to make any deductions and withholdings that Sponsors deem necessary or desirable under applicable federal, state and local tax laws, rules, regulations, codes or ordinances.

TRAVEL: Sponsor will determine all travel arrangements in its sole discretion. Airline reservations are subject to availability. Travel arrangements must be made through Sponsor's agent, on a carrier of Sponsor's choice. Certain blackout periods and travel restrictions may apply. Sponsor has the right in its sole discretion to substitute ground transportation for air transportation depending on First Round Finalist's and/or Grand Prize Winner's place of residence. Sponsor will not replace any lost or stolen tickets, travel vouchers or certificates. Once travel commences, no unscheduled stopovers are permitted; if an unscheduled stopover occurs, full fare will be charged from stopover point for the remaining segments, including return, of the trip. Finalist Audition Travel Expense and Trip may not be combined with any other offer and travel may not qualify for frequent flyer miles. Once determined, no change, extension, or substitution of Finalist Audition Travel Expense and/or Grand Prize travel dates is permitted, except by Sponsor in its sole discretion. No other travel elements (including, without limitation, accommodations, ground transportation, luggage fees, insurance, gasoline, meals, gratuities, souvenirs, etc.) are included in Finalist Audition Travel Expense or Grand Prize. Tickets are non-refundable and are not valid for business-related or group travel. Tickets are valid only for travel on the airline(s) chosen by Sponsor in its sole discretion. Tickets will be issued only to the applicable First Round Finalists and Grand Prize Winners. First Round Finalists and Grand Prize Winners are responsible for any tax liability, including applicable departure taxes or fees, inspection charges, and security charges. Once issued, tickets are nontransferable and may not be reissued once travel has commenced. Open tickets may not be issued and stopovers are not permitted. First Round Finalists and Grand Prize Winners must have valid travel documents (e.g., valid government-issued photo identification and passport) prior to

departure. Finalist Audition Travel Expense and Grand Prize consist only of the respective elements set forth above. Sponsor is not responsible for airline seat assignments, special meals, check-in procedures, and baggage limitations. Sponsor has no responsibility for alterations to any travel plans caused by airline delays or for any act, omission or event. Sponsor shall have no responsibility or liability for cancellations, delays, or any other change by any company or person providing any element of Finalist Audition Travel Expense and/or Grand Prize, and is not responsible or liable for any expenses incurred as a consequence thereof. First Round Finalists and Grand Prize Winners specifically release Sponsor from any and all claims for loss or damage to baggage or property, or from personal injuries or death, or from loss or delay, arising out of the acts, omissions, or negligence of any independent contractors, such as air carriers, hotels, restaurateurs, transportation providers, medical personnel or other providers of services or facilities. All travel and lodging will be at the risk of First Round Finalists and Grand Prize Winners.

**CONDITIONS:** By entering the Contest, each entrant agrees for entrant and for entrant's heirs, executors, and administrators (a) to release and hold harmless Contest Entities and their respective officers, directors, and employees (collectively, "Released Parties") from any liability, illness, injury, death, loss, litigation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from such entrant's participation in the Contest, including Finalist Audition (and any travel related thereto), and/or his/her acceptance, possession, use, or misuse of Grand Prize or any portion thereof (including any travel related thereto); (b) to indemnify Released Parties from any and all liability resulting or arising from the Contest and to hereby acknowledge that Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to Grand Prize, including express warranties provided exclusively by prize supplier that are sent along with Grand Prize; (c) if selected as a Grand Prize Winner, to the posting of such entrant's name on Website and the use by Released Parties of such name, voice, image, and/or likeness for publicity, promotional, and advertising purposes in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval, and, upon request, to the giving of consent, in writing, to such use; and (d) to be bound by these Official Rules and to waive any right to claim any ambiguity or error therein or in the Contest itself, and to be bound by all decisions of the Sponsor, which are binding and final. Failure to comply with these conditions may result in disqualification from the Contest at Sponsor's sole discretion.

**ADDITIONAL TERMS:** Sponsor reserves the right to permanently disqualify from any promotion any person they believe has intentionally violated these Official Rules. Any attempt to deliberately damage the Contest or the operation thereof is unlawful and subject to legal action by Sponsor, who may seek damages to the fullest extent permitted by law. The failure of Sponsor to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsor (excepting compliance with applicable codes and regulations), or other "force majeure" event will not be considered a breach of these Official Rules. Released Parties assume no responsibility for any injury or damage to entrants' or to any other person's computer relating to or resulting from entering or downloading materials or software in connection with the Contest. Released Parties are not responsible for telecommunications, network, electronic,

technical, or computer failures of any kind; for inaccurate transcription of Entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. Sponsor reserves the right to cancel, modify, or suspend the Contest or any element thereof (including, without limitation, these Official Rules) without notice in any manner and for any reason (including, without limitation, in the event of any unanticipated occurrence that is not fully addressed in these Official Rules). In the event of cancellation, modification, or suspension, Sponsor reserves the right to select Grand Prize Winners from among all eligible, non-suspect Entries received prior to the time of the event warranting such cancellation, modification, or suspension based on the Judging Criteria above. Notice of such cancellation, modification, or suspension will be posted at Website. Sponsor may prohibit any entrant or potential entrant from participating in the Contest, if such entrant or potential entrant shows a disregard for these Official Rules; acts with an intent to annoy, abuse, threaten, or harass any other entrant, Sponsor, or Sponsor's agents or representatives; or behaves in any other disruptive manner (as determined by Sponsor in its sole discretion).

DISPUTES: THE CONTEST IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY **FINAL** AND **BINDING** ARBITRATION ADMINISTERED BY JUDICIAL **ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS** STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY BE **ENTITLED** PARTY TO RECOVER PUNITIVE, **EXEMPLARY. CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES** OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
