## **GUIDELINES & RULES**





1. **ELIGIBILITY**: The Star Project (the "Contest") is open to: African Americans, persons of African descent, Latinos, Asians and Native Americans who are at least eighteen (18) years of age or older and a resident of the United States or District of Columbia at time of entry. Each participant in the Contest shall be referred to herein as an "Entrant."

2. CONTEST ADMINISTRATOR: American Black Film Festival ("ABFF")

3. SPONSORS: NBC Universal Inc. and NBCUniversal Media, LLC

4. CONTEST TIMELINE:

• January 24, 2014 Contest Opens • March 17, 2014 Contest Closes • April 14, 2014 Announcement of Finalists • May 1, 2014 Online Public Voting Opens • June 19, 2014 Finalists travel to 2014 ABFF in New York City • June 20, 2014 Online Public Voting Closes (12:00am EST) • June 21, 2014 Finalists' Live Auditions at 2014 ABFF in New York City • June 22, 2014 Announcement of Winners at "ABFF Honors" Presentation • June 23, 2014 Winners & Finalists Travel Home

HOW TO ENTER: Videotape yourself performing two monologues (one (1) monologue of your choice, one (1) mandatory monologue as supplied at www.abff.com) and submit your Video as a private online link (for example, an unlisted YouTube video, a password protected Vimeo, etc.) ("Video Link"). DO NOT SUBMIT A HARD COPY. Ensure your Video link is listed within your submission form. Submit your completed submission form, along with acting résumé via email to: diversity@nbcuni.com

By completing The Star Project submission form and submitting your monologues ("Video"), you agree that your submission materials ("Submission") will conform to The Star Project Guidelines and Content Rules as defined below (collectively, the "Guidelines and Rules") and that ABFF, in its sole discretion, may disqualify your Submission if it believes in good faith that your Submission fail(s) to conform to the Guidelines and Rules. The submission of a non-conforming Video shall result in your disqualification from the Contest.

#### Video Submission Guidelines:

- a) The Video must be the property of the Entrant
- b) You must include the Video as a private online link (for example, an unlisted YouTube video, a password protected Vimeo, etc.) ("Video Link").
- c) The Video must have been recorded within the contest period (January 24-March 17, 2014)
- d) The Video submitted must only include the image of the Entrant
- e) The Video must be in color
- f) The Video cannot have been submitted previously in a contest of any kind or exhibited or previously displayed publicly through any means now known or hereafter created

### Video Content Rules:

The Video must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or constitute copyright infringement.

The Video must not contain brand names, trademarks, photos, artwork or music.
