Mini Trial Divisions Offered:

JR/SR Baby Starter: True beginners, dressage test may be read. Dressage Test: 2015 USDF Introductory Test B. Stadium: Maximum 18". Cross Country: Ground poles up to 18" with the option to jump few starter jumps.

JR/SR Starter: Green horse/Rider. Dressage Test: 2015 USDF Introductory Test C. Stadium: Maximum 2'3". Cross Country: Maximum 2'3".

JR/SR Beginner Novice: 2014 Beginner Novice Test A. Stadium: Maximum 2'7". Cross Country: Maximum 2'7".

Combined Test Divisions Offered:

We will be offering a CT for Baby Starter through Preliminary. Baby Starter - Beginner Novice will run in conjunction with the MT.

Dressage Test(s) Offered:

Offering any USDF level tests or any USEF level test.

ALL DIVISIONS RUN OVER ONE DAY, ALL DIVISIONS WILL BE PINNED WITHIN 30 MINUTES OF END OF DIVISION. RIDERS MAY COMPLETE IN BOTH DAYS, AND EARN 42FDL POINTS FOR BOTH SHOWS.

Awards: Ribbons awarded 1-10, Prize to division winner.

Mini Trial Entry Fee: \$130 (\$10 discount to 42 FDL members – must have 42 number in order to receive discount). \$25 Late Fee assessed for entries received after close date.

Combined Test: \$65 for one division/ \$100 for two consecutive divisions.

Dressage Ride a Test Fee: \$25 per test

Stabling: Limited number of off-site stalls available. First come, first serve. \$35/night.

Dressage is first, followed by show jumping. Cross Country available immediately after. ALL times will be given, but jumping phases will have a block of time. Riders MUST jump between the times or they will be ineligible for prizes.

Everyone MUST have signed a release before getting on your horse! Medical Armbands or wristbands must be used in jumping phases, and vests must be worn in XC phase.

Organizer has the right to combine divisions if entries warrant.

Organizer has the right to cancel one day of show if entries warrant.
