Logistics

Works that hang on the wall should be presentation/exhibition ready. If the work requires a frame, plexiglass or glass must be used. If you are shipping your work to us and want it shipped back, please include return shipping package. The Art Center will not be responsible for paying to ship work back and insurance of work in transit is the sole responsibility of the artist.

Liability:

Your work is insured while on display. After the exhibition, if the work not picked up by the end of the scheduled pick up period, the artist bears all responsibility for loss or damage. Unless prior arrangements have been made with the staff, all work will become property of the SHCA after 30 days past the pick-up period. Please provide notification in advance if someone else is picking up for the artist.

Sales & Reproduction:

Exhibited work may be sold at the price specified on the entry form. A commission of 35% is received for works sold during the exhibition, so price accordingly. If work is not for sale, please include an estimated value on the entry form provided. Accepted work may not be substituted or withdrawn before the close of the show. The SHCA reserves the right to photographically reproduce accepted entries for publicity purposes.
