## **POWERS OF A CHARTERED CHAPTER**

1. To retain its Charter until lawfully surrendered, suspended or revoked.
2. To fix its time and place of meeting.
3. To meet and do all work of Eastern Stardom.
4. To elect and initiate members and reject any application of membership.
5. To elect and install its officers.
6. To make laws requiring its members to contribute to its funds.
7. To instruct its representatives, for their government, at all communications of the Grand Chapter and the Ashique' Ladies' Council of United National.
8. To place on trial, for cause, its own members, sojourners and unaffiliated Eastern Stars living within its Jurisdiction.
9. To appeal to the Grand Matron and Grand Chapter to decisions of the Matron.
10. To make By-Laws for its local government.
11. To be represented in all communications of the Grand Matron.
12. To protection while in the lawful exercise of its inherent rights.
13. To the enjoyment of all powers conferred by the Grand Chapter, United National Supreme Council upon any constituted Chapter.

All local chapters will hold election of officers the first meeting in December of each year. Their officers will be installed at this meeting or as soon thereafter as possible.
