## Waiver and Release of Liability

In consideration of being allowed to participate in the services and activities of QUARANTINE: THE CURSE ("QUARANTINE"), provided by BLACKOUT THEATRE COMPANY, LLC and its agents, owners, officers, directors, principals, volunteers, participants, clients, customers, invitees, employees, independent contractors, insurers, facility operators, land and/or premises owners, and any and all other persons and entities acting in any capacity on its behalf (collectively "BLACKOUT"), I, on behalf of myself, and/or on behalf of my minor child(ren)/ward(s), hereby agree to forever release, indemnify and discharge BLACKOUT on behalf of myself, my spouse, legal partner, my children, my parents, my guardians, heirs, assigns, personal representatives and estate, and all other persons and entities who could in any way represent me or act on my behalf as follows:

**INITIAL RELEASE OF LIABILITY:** Despite all known and unknown risks, I hereby expressly and voluntarily remise, release, acquit, satisfy and forever discharge BLACKOUT and agree to hold it harmless of and from all, and all manner of action and actions or omission(s), cause and cause of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties covenants, contracts, controversies, agreement, promises, variances, trespasses, damages, judgments, executions, claims and demands whatsoever, in law or in equity, including, but not limited to, any and all claims which allege negligent acts and/or omissions committed by BLACKOUT, whether the action arises out of any damage, loss, personal injury, or death to me or my child(ren)/ward(s), while participating in or as a result of participating in QUARANTINE. This Release of Liability, is effective and valid regardless of whether the damage, loss or death is a result of any act or omission on the part of BLACKOUT.

**INDEMNIFICATION:** I hereby agree to indemnify and hold harmless from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred and/or suffered by BLACKOUT, including, but not limited to, any and all attorneys' fees, costs, damages and/or judgments BLACKOUT incurs in the event that I or my minor child(ren)/ward(s) cause any injury, damage and/or harm to BLACKOUT and/or any and all other persons and entities acting in any capacity on behalf of BLACKOUT.

**PHOTO RELEASE:** By entering BLACKOUT and participating in QUARANTINE, I hereby grant BLACKOUT on behalf of myself and on behalf of my child(ren)/ward(s), the irrevocable right and permission to photograph and/or record me or my child(ren)/ward(s) in connection with BLACKOUT and to use the photograph and/or recording for all purposes, including advertising and promotional purposes, in any manner and all media now or hereafter known, in perpetuity throughout the world, without restriction as to alteration. I waive any right to inspect or approve the use of the photograph and/or recording, and acknowledge and agree that the rights granted to this release are without compensation of any kind.
