### Who are we?

- We are a community based nonprofit organization with 501(c)(3) status based in Pacifica, California
- We were established in 1982 by a small but dedicated group of Pacificans who "accepted the challenge to assist and support essential, locally administered service agencies in order to build a broad and higher quality of life for Pacificans."
- We raise funds to support local social service organizations and projects
- We are the only Pacifica organization solely dedicated to supporting social services for the community, from children and families to seniors.

## What Do We Do?

- We support community agencies:
  - Pacifica Childcare
  - Pacifica Senior Services
  - Pacifica Resource Center
     "A Project of the Tides Foundation"
  - Youth Services Bureau
     "Affiliated with YMCA"
- We provide the necessary nonprofit umbrella for numerous community projects, including "Project Play!" Fire-Cam, Pacifica Skate Park, Pedro Point Playground, and Pacifica Realtors Community Service (PRCS) group
- We fund mini-grants to support local community social service projects

### With Your Donation

- We help the Pacifica Resource Center continue to provide critical services to Pacifica families who are struggling to make ends meet. These services include:
  - safety net and emergency services
  - financial assistance for delinquent rent
  - moving costs
  - transportation
  - financial education and coaching
  - asset-building strategies
  - free tax preparation
  - matched savings programs
- We help the Pacifica Senior Services Program continue to provide services that support healthy, physical and emotional well-being for our frail and elderly residents. These services include:
  - transportation for seniors to the Community Center who would otherwise stay-at-home
  - nutritious meals to homebound frail seniors and disabled who would otherwise struggle to eat
  - encouraging Meals on Wheels clients to periodically visit the Center for activities thereby reducing isolation
  - providing trips to and from doctor appointments
  - providing local shopping trips and excursions
  - respite for family caregivers

- We help the Pacifica Youth Services Bureau continue to support and nurture families by providing accessible and affordable mental health services to Pacifica families. Our yearly grant helps:
  - provide hardship fee subsidies for low income and working class families to receive counseling services at PYSB
  - place an MFT Counseling Intern at Terra Nova High School for on-site counseling services and referrals for adolescents struggling with anxiety, depression, and other mental health conditions
- We help the Pacifica Childcare Program provide summer enhancements and scholarships for children in the community to attend recreation field trips and swim lessons. The majority of children in summer childcare receive free or reduced care, which does not support these enrichment activities. The philosophy of the PCC Program is for every child to be treated the same, regardless of income.
