THE PROBLEM AMERICA FACES

Wasteful, outdated regulation hobbles American workers and businesses, making them internationally uncompetitive and impoverishing the nation.

It is increasingly difficult to start a business, or to find gainful, high quality employment, and save for retirement. The stifling of fair competition to serve special interests is placing a regulatory burden on Americans that can no longer be ignored. Considering also that inequitable tax policies bear no relationship to government services provided, it is now undeniable that the American Dream is disappearing.

Other attempts at creating deep and lasting regulatory and fiscal reform have largely failed. Prosperity Zones offer the best and fastest way to advance necessary reforms with minimum friction and maximum effect.

THE SOLUTION: PROSPERITY ZONES

States can ignite economic growth and opportunity by creating Prosperity Zones, wherein obsolete policies are replaced by a 21st century regulatory framework that maximizes opportunity for all.

Prosperity Zones are mixed-use spaces, developed in greenfield sites, that enable Americans to live and work in environments with a strong protection of rights and freedom from cronyism.

MODEL LEGISLATION

- ★ Establishes the procedures for the voluntary creation of Prosperity Zones by residents, and tailors them to each state's needs.
- ★ Creates a revenue sharing agreement between Prosperity Zones and the state that provides incremental revenue to the state from wealth generated in the Zones.
- With congressional consent, it replaces select federal laws and regulations within Prosperity Zones with more effective alternatives.

PROSPERITY ZONES: THE FUTURE OF PROSPERITY

What if a small, underutilized land area was cleared of wealth destroying state and municipal regulations, and was injected with reforms proven to maximize well-being and opportunities for all?

What if this reform could include the replacement of similarly unreasonable federal regulations that demonstrably stifle economic progress and prosperity?

What if this reform could expand over time as it demonstrates its power to ignite economic growth and job creation?

A coalition including Compact for America Educational Foundation, NeWAY Foundation and Federalism in Action is working to educate citizens and policy leaders on the merits of a model interstate compact that will enable member states to catalyze rapid productivity growth by:

Establishing a process for Prosperity Zones to emerge on underutilized land of at least one square mile in size.

Enabling the development of new communities for citizens to live, work and prosper in, at no cost to the taxpayer.

HOW IT WORKS

Prosperity Zones are created as new municipalities designed to prevent cronyism from taking hold.

The interstate compact which underpins this policy creates Zones which:

- Increase revenues to the state without increasing taxes
- Target regulatory authority to serve the needs of 21st century citizens
- Guarantee equality before the law
- Maximize job creation and investments to boost productivity

This policy achieves the deepest and most durable opportunity-maximizing reform possible.
