MUST HAVE A EMAIL!!!

Government Issued Picture ID for all ADULT in Household.

Original Birth Certificates for all CHILDREN in the household (under 12 years old)

Custody papers are required in the absence of the Birth parent.

Proof of Residency: Lease Agreement w/Rent Amount including Section 8 cover statement (if applicable)

.Income Verification for the past 4 weeks: Verification must include both Earned & Unearned Income.

Earned income includes but is not limited to: pay stubs, employer verification statements.

Unearned income includes but is not limited to: food stamps verification statements, SSDI, SSI, Child Support, Pensions, Unemployment Compensation, Workman's Compensation, etc.

Utility Bills: Last or most current (Electric, Water, Gas)

Certificado original de nacimiento de todos los niños del hogar (menores de 12 años).

Documentos de custodia del niño(s) son requeridos si los padres biologicos no estan presentes

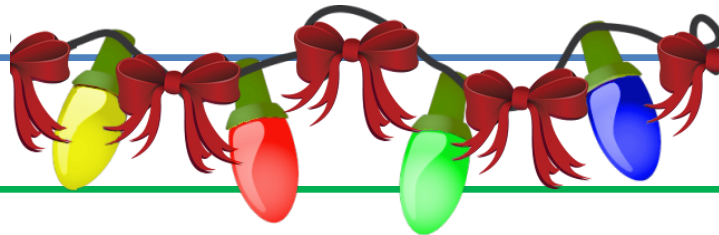
Verificación de Ingresos de las últimas 4 semanas.

Verificación de ingresos debe incluir INGRESOS GANADOS Y NO GANADOS.

El ingreso del trabajo incluye, pero no es limitado a: talones de pago, verificación de trabajo de su empleador.

Los ingresos no derivados del trabajo incluye, pero no es limitado a: Carta de declaracion de cupones/estampillas de alimentos, SSDI, SSI, Ayuda de los hijos, pensiones, seguro de desempleo, compensación de trabajadores, etc.

Facturas de servicios públicos: Por favor traer el ultimo pago o el mas reciente de: electricidad, agua, gas.
