Programs may also be submitted for consideration on DVD/Blu-ray, Flash Drive, or Hard Drive, and through ftp and file sharing sites such as dropbox.com , Google Drive , wettransfer.com , mega.nz . etc.

The following 3-D layouts are accepted:

Side-by-side (squeezed or full) Left on left. Over/Under (squeezed or full) Left on top.

The following resolutions are accepted:

SD 480p(720×480), HD 720p (1280×720), HD 1080p (1920×1080), XGA (1024×768), SXGA+ (1400×1050)

The following file compressions are accepted:

MPEG4, XVID, h264, WMV, MPEG2

For festival selection screening, we prefer unencrypted 3-D DCP (Digital Cinema Package) for projection. These should be submitted on NTFS formatted flash or hard drives and conform to the SMPTE standard.

Eligibility: Films/videos must be produced and/or directed by the entrant. Previous entries are not eligible.

Judging Criteria: Submissions will be judged on image quality within the limitations of the format, creativity, 3-D effect, editing and story. Award categories will be established based on submitted content.

Liability: All possible care will be exercised in the handling of entries, but no responsibility is assumed for loss or damage of entries during judging or transit. Submission of entries will imply acceptance of all conditions.

The entrant declares that he/she has complied with all the rules of the competition and has the necessary authority to convey all rights, titles and interest in the above-titled work to the LA 3-D Movie Festival to display the work. Permission is also granted to use excerpts from the submitted work, if selected, in promotional works for the LA 3-D Movie Festival, and to include the work in future screenings sponsored by the LA 3-D Movie Festival and its organizers, 3-D SPACE and the LA 3-D Club. All ownership and other rights are retained by the entrant, including full copyright protection.
