PART 4: ELIGIBILITY REQUIREMENTS

If selected as a participant I will execute waivers and release agreements required by Network or any of its licensees, successors or assigns. In addition, I will authorize Network to investigate, access, and collect information about me and any of the statements made by me in connection with my application to participate in the Project and I agree to execute any background check forms or additional authorizations that Network deems necessary to conduct a background check and/or gather information about me.

I understand that being chosen to interview at any level for the Production does not ensure that I will be selected to continue the through the selection process or ultimately be selected as a participant in the Production.

PART 5: RELEASE & WAIVER

This release (the "Release") is made by and on behalf of _____ ("Applicant") with respect to Applicant's participation in a program and/or programs tentatively entitled "Bend, Oregon" (collectively, the "Production") being produced for the programming service which will exhibit and/or distribute the Production ("Network").

1. For good and valuable consideration (including, without limitation, the effort and expense incurred by Network procuring the Recordings (defined below) and otherwise producing the Production and considering use of such Recordings in the Production), the receipt and sufficiency of which are hereby acknowledged, Applicant irrevocably grants Network the perpetual, worldwide right to make visual and/or audio recordings and still images of Applicant, whether recorded prior or subsequent to the execution hereof, with or without Applicant's knowledge (collectively, the "Recordings") and to use the Recordings and Applicant's name, voice, likeness, and biographical information ("Applicant's Likeness") as included in the Recordings and/or otherwise obtained by Network, in and in connection with the Production, and any version thereof, as Network may determine in its sole discretion. Applicant authorizes Network to incorporate and license others to incorporate any part or all of the Recordings and/or Applicant's Likeness in the Production and in any other production. Applicant grants Network the right to use the Recordings and/or Applicant's Likeness for the purpose of advertising and promoting the Production or any version thereof and/or any other production in which the Recordings and/or Applicant's Likeness is incorporated and/or the exhibitors (including, but not limited to, institutional promotion) and sponsors of any of the foregoing in any manner whatsoever, including, but not limited to, product integration, commercial tie-ins, and implied endorsements. Without limiting the generality of the foregoing, Applicant agrees that the rights granted hereunder shall include the perpetual, worldwide right of Network to edit, telecast, cablecast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit, in any manner and in any medium or forum, whether now known or hereafter devised, the Production or any version thereof or any other production in which the Recordings and/or Applicant's Likeness is incorporated, in whole or in part, without any compensation to Applicant.

2. Network shall be under no obligation to actually use the Recordings and/or Applicant's Likeness in any manner.

3. In the event of breach by Network, Applicant acknowledges and agrees that the damage, if any, caused thereby will not be irreparable or otherwise sufficient to entitle Applicant to injunctive or other equitable relief; Applicant's remedy in such case being strictly limited to the right to recover damages, if any, in an action at law. Applicant understands that Network is expending monies in reliance on this Release and that this Release is irrevocable.

4. Applicant will not at any time issue, authorize or participate in any news story, magazine article or other publicity or information of any kind relating to the Production, Network or any of its related or affiliated entities or disclose any confidential information, including without limitation the terms of this Release, without Network's written consent in each case. Additionally, Applicant shall have no right to use the names, trademark, logos, or trade names of Network, its parent, subsidiaries, affiliated entities, or the names or logos related to the Production for any purpose whatsoever, including but not limited to, publicity, public relations, merchandising or self promotion purposes without the prior written consent of Network. Any violation of this Paragraph will be deemed a material breach of this Agreement which will cause irreparable harm to Network, entitling Network to seek (without limiting any other rights or remedies Network may have) (i) injunctive relief, without posting any bond, to prevent and/or cure any breach or threatened breach of this Paragraph by Applicant, (ii) recovery or disgorgement of the monies or other consideration received in connection with such disclosure, if any, (iii) recovery of Network's attorneys' fees incurred to enforce the terms of this Paragraph, and (iv) return or recovery of any compensation received in connection with Applicant's Services under this Agreement.

5. The rights granted herein shall inure to the benefit of Network, its licensees, successors, and assigns.

6. Applicant acknowledges that Applicant's participation and appearance hereunder and any other services rendered in connection with the Production are not subject to the terms of any collective bargaining agreement.

7. Applicant acknowledges that participation in the Production may involve risk of bodily injury, death and/or damage to or loss of property, and Applicant expressly assumes all risk and danger and all hazards arising from, or related in any way to, Applicant's participation in the Production, however caused and whether by negligence or otherwise. Applicant hereby agrees on behalf of Applicant and Applicant's heirs, next of kin, representatives, successors and assigns (collectively, the "Releasing Parties") that Applicant and the other Releasing Parties do hereby unconditionally and irrevocably release and discharge Network and each of its parent, subsidiary and affiliated entities and each of their employees, directors, shareholders, officers, agents, sponsors, successors and assigns (collectively, the "Released Parties") from any and all past, present and future claims, demands, damages, judgments or liability of any kind directly or indirectly related to or arising out of the Production and Applicant's voluntary participation in the Production, including but not limited to claims for any personal injury, property damage, libel, slander, defamation, infringement of right of publicity, invasion of privacy, false association or false endorsement, whether or not caused by any negligence or act or omission of the Released Parties. Applicant on behalf of Applicant and the other Releasing Parties acknowledges and understands that there may be facts discovered or claims incurred which were unknown or unsuspected at the time of execution of this Release which may have materially affected Applicant's decision to execute this Release if known at the time of execution, and Applicant and the other Releasing Parties assume any risk of such unknown or unsuspected facts or claims.

8. This Release constitutes the entire agreement and understanding between the parties regarding the subject matter hereof, and cancels and supersedes all prior or contemporaneous agreements, communications and understandings (whether written or oral) between the parties relating to the subject matter hereof. Applicant confirms that Applicant has read and fully understands this document, and has not signed it in reliance on any statement, opinion or representation by Network, or anyone acting on their behalf or otherwise. The Parties will be bound by signatures on this document which are transmitted by mail, hand delivery, facsimile and/or any other electronic method (email or otherwise) to the other Party or, if applicable, counsel of record for the other Party. Such signature will have the same binding effect as any original signature. In the event that any term or provision of this Release shall be held invalid by a competent court or governmental agency, the remainder of this Release shall not be affected thereby, and the parties hereto shall continue to be bound by the remaining terms hereof. This Release can only be amended by a written document signed by all parties hereto. This Release shall in all respects be governed by, and construed in accordance with, the laws of the State of California applicable to contracts entered

into and to be fully performed therein, and the parties hereto submit to the exclusive jurisdiction of the Federal or State Courts in Los Angeles, California. Nothing herein shall limit or derogate from Network's rights as a member of the general public.
