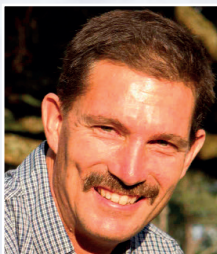

Beatrice Mtetwa, an award-winning human rights lawyer: Fearless, feisty and indomitable, Beatrice has been an inspirational giant for all Zimbabweans as she has fought injustice - and been tortured by police for so doing. This lion-hearted lady is a lawyer in a million - and a "must hear".

Paramount Chief Nhlanhla Felix Ndiweni: Felix is a brave, outspoken man committed to justice. He commands great and growing respect for his confident courage in the face of tyranny. He has been unjustly imprisoned and stripped of his Chieftainship by the President.

Ben Freeth MBE has been in the firing line as a result of his involvement in taking Mugabe to court. He's been abducted, tortured, shot at and had his house burnt down in his continued adamant belief in standing for the rule of law and property rights in the violent land nationalisation programme of the last 20 years and with new leaders in charge, the battle still rages in Zimbabwe. As Executive Director of the MCF, he also oversees the MCF's humanitarian projects in Zimbabwe.

Murray Hunt, Director of the Bingham Centre for the Rule of Law and the newly created Modern Slavery and Human Rights Policy and Evidence Centre. He is the UK's alternate member of the Council of Europe's Commission for Democracy Through Law (the Venice Commission). He previously worked as Legal Adviser to the Joint Committee on Human Rights in the UK Parliament and as a barrister with a wide-ranging practice in public law and human rights.

Dr Jan Van Zyl Smit is a Senior Research Fellow and Director of the Justice Systems and Rule of Law Programme at the Bingham Centre for the Rule of Law. Much of his work focuses on the use of legal frameworks to foster and protect the independence of the judiciary. Jan studied Law in South Africa before starting his academic career in the UK. His work on the judiciary includes comparative studies of African judicial systems in the Commonwealth, and he worked as a consultant on judiciary reforms in Kenya between 2012 and 2016.
