All publicity and advertising rights are hereby reserved by Connell Fall Festival.

Connell Fall Festival reserves the right to restrict vendors to acceptable behavior during any and all events/activities. This reservation includes persons, things, conduct, printed matter, or any act or item of poor character which the Connell Fall Festival considers objectionable to the event's well-being. In the case of any eviction or restriction, Connell Fall Festival will NOT refund vendor fees.

To get to Pioneer Park from Columbia Ave. turn east on Birch Street and drive straight four blocks to the end of the street where there is parking. Check in at the information pavilion located just south of the restrooms.
