



PAY FOR YOUR HEATING FUEL ON OUR EASY BUDGET PLAN

Right now – while you’re thinking about it – let us convert your account to our BUDGET PAYMENT PLAN. Under this plan, we estimate your total fuel bill on the basis of past usage. The total is divided into twelve (12) equal monthly payments.

Budget customers receive a FIVE (.05) CENT PER GALLON DISCOUNT at the time of delivery.

**BUDGET PAYMENT PLAN – Terms and Conditions**

1. You must have approved credit with Foster Blue Water Oil LLC.
2. Current account balance must be paid in full before budget begins.
3. Budget payments are due the 10<sup>th</sup> of each month, beginning July 10<sup>th</sup> and ending May 10<sup>th</sup>. If we do not receive your payment by the last day of the month, you will be removed from the Budget Plan. The balance owing when removed from the Budget Plan will be due in full within 30 days.
4. June is the settlement month for the Budget Payment Plan. Unpaid balance will be due and payable by June 30<sup>th</sup>. Overpayments at May 31<sup>st</sup> will be applied to your next heating season unless you notify your local office to request a refund. Customers in good standing will remain on the Budget Plan until the customer notifies Blue Flame Propane, Inc. in writing they want to be removed from the Budget Payment Plan.
5. Budget payments are due the 10<sup>th</sup> of each month, beginning July 10<sup>th</sup> and ending June 10<sup>th</sup>. If we do not receive your payment by the last day of the month, you will be removed from the Budget Plan. The balance owing when removed from the Budget Plan will be due in full within 30 days.
6. Unpaid balance will be due and payable by June 30<sup>th</sup>. Overpayments at May 31<sup>st</sup> will be applied to your next heating season unless you notify your local office to request a refund. Customers in good standing will remain on the Budget Plan until the customer notifies Foster Blue Water Oil LLC. in writing they want to be removed from the Budget Payment Plan.
7. Monthly payments may be adjusted at the company’s discretion if the price of product or consumption warrants a change. Should usage vary significantly from the prior year due to changes in supplemental heat, remodeling, additions, etc., the consumer should contact the local fuel office for budget review.
8. Customers will be notified via letter in June the new monthly payment calculation.
