Looking for an opportunity to practice hands-on skills in anthropological methods and get involved with real-world experience? Sweet Grass Consulting, LLC (SGC) partners with organizations and communities to provide services and opportunities for economically impoverished communities throughout the United States. Currently, SGC is involved with a housing market study on the Pine Ridge Reservation in South Dakota.

**Thunder Valley Community Development Corporation has invited Sweet Grass Consulting to conduct surveys in order to determine housing needs on the Pine Ridge Reservation.** The surveyors, local Oglala Lakota and SGC (with the help of interns!), will be collecting approximately 300 surveys from a portion of all communities throughout Oglala country. Information from these surveys will be analyzed and reported on for the purpose of increasing the ability to provide different housing opportunities on the reservation. The internship will take on the Pine Ridge Reservation for **May 17<sup>th</sup>-22<sup>nd</sup>**. Then, interns will be responsible for **32 hours within the span of 3-4 days** of data analysis in Excel.

Interning with SGC is a good way to learn new skills and prepare for the job force. If you are a student or anyone looking for professional development in a real-world, applicable setting, internships can be a valuable addition to your resume. Many schools will offer credits for internships or independent research.

You will not regret the experiences and growth you will encounter while visiting the rich environment and working with vibrant people throughout the area.

## Mutual Nondisclosure Agreement

This Mutual Non-Disclosure Agreement (“Agreement”) is made of the latest signing date below between Sweet Grass Consulting, LLC and the participating intern or employee named below. The intern or employee recognizes that there may be a need to disclose confidential information related to the Business Purpose. The parties agree that their mutual objective under this Agreement is to provide appropriate protection for maintaining the secrecy of information as follows.

**1. Confidential Information:** “Confidential Information” means any information disclosed by one party to the other, either directly or indirectly in writing, orally, or by observation that the disclosing party (“Discloser”) identifies orally or in writing as confidential at the time of or within 30 days of disclosure.

**2. Non-Disclosure:** Sweet Grass Consulting, LLC will (a) hold Discloser’s Confidential Information in confidence and (b) not use any Confidential Information for any purpose except for evaluation of, and to carry out, the Business Purpose, and (c) not disclose to any third party (without written consent of Discloser) any Confidential Information. The intern or employee, indicated by a signature below will (a) hold Discloser’s Confidential Information in confidence and (b) not use any Confidential Information for any purpose except for evaluation of, and to carry out, the Business Purpose, and (c) not disclose to any third party (without written consent of Discloser) any Confidential Information.

**3. Term:** The terms of this Agreement will remain in effect with respect to any particular Confidential Information until the internship or employment is complete, at which time the intern or employee will no longer maintain or be granted access to the Confidential Information.

**4. Assignment & Amendment:** This Agreement is not assignable nor may be modified without written consent by Sweet Grass Consulting, LLC.

**5. Governing Law, Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of the State & Country of the Discloser’s headquarters. The parties agree that any disputes arising at any time shall be decided by a reference to a private judge, mutually selected by the parties; or, if they cannot agree, by the presiding judge of the jurisdiction of Discloser’s headquarters location. The prevailing party in any dispute or legal action regarding the subject matter of this Agreement shall be entitled to recover attorney’s fees and costs from losing party. If any provision is found to be unenforceable, such provision will be deleted to the minimum extent necessary so that the remaining terms remain in full force and effect.
