**Rules & Regs- All players in the 18's must sign-up online with their IPIN. No fax entries to the USTA will be accepted for the 18's. This is an ITF Grade 1 Tournament. All players must register for a hotel prior to arrival. The withdrawal deadline (online through IPIN for 18's) for all ITF Junior Circuit tournaments will be 1400 GMT 13 days prior to the Monday of the tournament week. Player will be able to withdraw without penalty until that time. The Freeze deadline for all ITF Junior Circuit tournaments will be 1400 GMT on Wednesday, five days prior to the Monday of the tournament week. From that time players who are on the qualifying list will no longer move into the main draw and players who are alternates will no longer move into qualifying. Vacancies onsite will be filled by signed in alternates (qualifying) and lucky losers (for main draw). It is the player's responsibility to enter and withdraw with their IPIN, the players must be aware of deadlines so as not to be penalized.
