'Christmas in July' Arts & Craft Show

The Sioux Empire Farmers Market is excited to present the first annual '**Christmas in July**', an event that will take place in conjunction with the weekly market encouraging locally made items.

Participation is open to all artists and fine crafters who exhibit work of original concept, design and execution. Only hand crafted work by the selling artist is acceptable. **No** commercial or mass produced products, molds, kits, patterns or resale items will be permitted.

Schedule:

Postmark deadline for entry consideration is May 8, 2015; email entry is encouraged.

Exhibitor will be notified of selection no later than May 18, 2015

Exhibitor fee will be paid in full no later than May 28, 2015

Information of space assignments will be communicated by June 22, 2015

Booths will be setup and ready by 9:00am, July 25, 2015; booths can begin knocking down at 4:30pm.

How to Apply:

- Complete the attached application form.
- Include a self-addressed, stamped envelope for return of notification if e-mail address is not available.
- Include 3-5 jpeg images of your work and a short description of the process/work
- If application is mailed images may be submitted on paper if they are of high quality otherwise they must be submitted on a CD which will not be returned.
- If application is e-mailed the combined file size for images will be no larger than 1mg (zip file if possible)
- It is important to submit images that best represent your work.

Rules & Event Information

- **Christmas in July** will take place with the Sioux Empire Market at 8th & RR Center, Downtown East Bank, Sioux Falls SD.
- **Booth Fee:** \$35
- **Booth size:** 10'W x 16'D
- **Sioux Empire Market is not responsible for any loss, theft or damage.** Each Vendor is highly encouraged to carry personal and product liability insurance
- **Electricity** will not be provided
- **Booths will be reviewed** on the day of the show. Work must be consistent with images submitted or the artist will be asked to leave
- **State and City sales tax** is the artist's responsibility
- **The event will take place even in inclement weather** (rain, wind, etc) Artists should be prepared for these elements and are responsible for the protection of their work.
- **Fee will be non-refundable**
