

**Student Association Vote of No Confidence For:
Benedict Sponseller, Stephen Ruff, Robert Pastoor, Greg Roberts, and Spencer Conroy**

As of the 8th day of February in the year 2017, Chairmen of the Board Benedict Sponseller, Vice Chairmen of the Board Stephen Ruff, President Robert Pastoor, Vice President of Institutional Advancement Greg Roberts, and Vice President of Business Affairs Spencer Conroy have officially lost the confidence of the student body, leading to this, a Vote of No Confidence by the Student Association. The reasons for this motion are as follows:

1. Failed to directly communicate issues to students as pertaining to our right to know about the financial state of the College
2. Did not exhaust all options to keep the campus open for the Fall 2017 semester
 - a. Placed all of the college's financial future into a hasty and highly risky endeavor to sell the Waugh property without understanding and addressing the impact the loss of an annual 2 million dollars would have on the College
 - b. Failure to communicate to State Government officials
 - c. Failure to reach out to the greater Rensselaer community
 - d. Systemic failure to keep the alumni community informed about the financial state of the College
 - e. Ignored all emergency fundraising efforts provided by the alumni after receiving the alarming Presidential Discourse and resulting media blackout
 - f. Poisoned the fundraising well with the Presidential Discourse email and following media blackout

- g. Made it so that even if the College remains open for the Fall 2017 semester both enrollment and retention will have dropped to an unsustainable rate due to the Presidential Discourse email and resulting media blackout.
 - h. Did not cut the 1.8 million dollars that the faculty reallocated with the raise to an 8 student minimum
 - i. Overpaid (as compared to position median salaries) an under qualified and underperforming Vice President for Institutional Advancement with a personal connection
- 3. Authorized the Presidential Discourse, which had severe college life threatening implications, without the approval of the full board of Trustees
- 4. Repeated attempts (both successful and unsuccessful) to remove the Student and Faculty Board Representatives when important issues were being discussed
- 5. Failed to address the questions of the students in the February 6th, 2017 Q&A session in a tone and manner that was required for as somber of an issue as it was
- 6. Failed to keep on record promise to the students that we would be accredited until at least 2022, and that the Class of 2018 would be graduating from the Rensselaer campus
- 7. Recruited the Class of 2020 and the potential Class of 2021 despite knowing the perilous financial situation that the College was in
 - a. Hosted the Presidential Scholarship Competition amid this financial crisis, and made potential students travel across the area wasting both precious time and money
 - b. Allowed athletes to pass signing day, signed with the College

8. Created a hostile learning environment due to the physical, emotional, and psychological stress resulting from the 10 day media blackout after the Presidential Discourse email and the 72 hours following the haphazard announcement by Chairmen of the Board Benedict Sponseller
9. Allowed the cash flow of the College to reach a point so low that we are declaring a state of financial exigency in the middle of the Spring 2017 semester and hoping for a favorable decision from the Attorney General in order to free up endowment money to pay out severance packages

Let it be formally known that the Student Association formally requests that each of the above listed people are removed from their position as soon as possible in order for the possibility of a better Saint Joseph's College to come about in their absence. We the Student Association feel as though as long as these five men are still involved in the operation of the college, nothing will be accomplished to rectify our current situation as these men are clearly not, "Involved For Life."
