MECHANICAL COMPONENTS:

1. One (1) N.O. Pull Away (firearm deployment) Switch.
2. One (1) N.O. Plunger (pressure tamper) Switch.
3. One (1) N.C. recessed (magnetic tamper) Switch located between the SHUNT LOCK and the PULL AWAY CABLE RECEIVER TUBE.
4. One (1) Keyed Shunt Lock Switch wired in parallel to the initiation circuit.

6. User's Guide:

TEST YOUR SYSTEM WEEKLY!

Periodic testing is the only true way to ensure your alarm system and all of its components are functioning properly.

ATTENTION USER: Activation of an alarm by **The Pistol Pad** is normally handled as a PANIC situation and your alarm company **WILL NOT CALL** your location to verify.

If you have activated the alarm in error, in order to stop emergency response, you **MUST**:

- call** your alarm company immediately;
- identify** yourself properly; and
- instruct** them to abort the alarm.

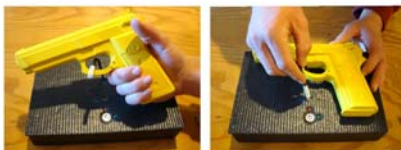


1. The key lock turned to the **GREEN** indicator means **The Pistol Pad** is disarmed.



2. The key lock turned to the **RED** indicator means **The Pistol Pad** is armed.

1. The PULL AWAY CABLE **must** be pulled up through the trigger guard, then down into the receiver tube. Reversing this procedure may cause the probe to hang up on the trigger guard when the weapon is deployed.



2. The PULL AWAY Cable's white probe should sit in the receiver tube and move freely. Do Not press the probe into the receiver tube. This may cause it to stick in place and restrict deployment of the weapon.
3. If **The Pistol Pad** has initiated an alarm and you want to silence the sirens:
 - A. reset or disarm **The Pistol Pad**, then
 - B. silence and reset your alarm system at the keypad.
4. If you want to deploy the weapon without initiating an alarm:
 - A. Move the SHUNT LOCK to the GREEN disarmed position.
 - B. Remove the weapon.
 - C. TEST **The Pistol Pad** at least once every week in compliance with your alarm company's recommended procedures.
5. Practice removing the weapon from **The Pistol Pad**.
6. Make anyone, who may have access to the area where **The Pistol Pad** is placed, fully aware of what will happen if the weapon is manipulated.

Overview

The Pistol Pad is a tamper resistant, alarm initiation platform. When interfaced with an electronic alarm system (or other alarm annunciating device), **The Pistol Pad** allows immediate weapon access to the "right" people while severely limiting clandestine weapon access by the "wrong" people.
