

MacCallum More Museum and Gardens
Juried Art Show with \$1,200 Total Prize Money - Rules (Revised February 2017)

MacCallum More Museum and Gardens (MMM&G) is sponsoring a Juried Art Show with \$1,200 in total prize money. The show will be held at the historic MacCallum More Museum and Gardens at 603 Hudgins Street, Chase City, Virginia from June 8, to July, 27, 2017, and will offer a \$500 first prize, \$300 second prize, \$150 third prize, and a \$250 MacCallum More Garden Award for the best depiction of the MacCallum More Gardens. The Juror is Henry Kidd.

WHAT CAN BE ENTERED

Two-dimensional, original artwork on paper, canvas, or board conceived and created by the entrant, will be considered. Work cannot have been created under supervision. If the work is a collage, the collage materials must be original to the artist, and created by the artist. Work must be appropriate for a family audience, and the maximum outside frame size must not exceed 40 inches in any direction. Paintings that are on canvas and wrapped around the edges are acceptable unframed, provided that the edges are painted, and that no staples show. All other work must be appropriately framed with a hanging wire attached (no saw-tooth hangers). All artwork must be for sale.

ENTRY FEE

There is a \$10 non-refundable entry fee for each piece of artwork submitted, with no limit on the number of works that you may submit. No work will be considered without the appropriate entry fee. A completed entry form must accompany submissions – use additional forms if needed. No more than two (2) pieces from any one person will be selected to be in the show and, since this is a juried show, there is no guarantee that artwork will be selected. Artists will be notified whether works were selected on May 23, 2017 (email preferred).

HOW TO SUBMIT WORK FOR CONSIDERATION

1. By email: the shortest side of the photo should be no smaller than 1200 pixels (4”). Send to:

2. On one CD, (one image per painting) in JPEG format at 300 dpi resolution. CDs will not be returned. Send to:

Crop to show only the image, without text, matting, frame, or background. Files (photos) should be named as follows: Last name-first name-entry#-title.jpeg Example: doe-jane-1-flowers.jpeg

Artwork that differs substantially from the photos may be disqualified.

All artwork submitted by email or CD must be emailed or postmarked by May 13, 2017.

3. Artwork may be dropped off in person at MMM&G on Saturday, May 13 (10 a.m.- 4 p.m.), or Saturday, May 20 (10 a.m. to 4 p.m.).

All work must be identified on the back with the artist's name, phone number, name of work, price, and medium. Artwork delivered to MMM&G, but not selected for the show, must be picked up May 24 through May 27, 2017.

ACCEPTED WORK AND MUSEUM COMMISSION

Artwork selected for the Show from email and CD entries must be delivered by the artist to MMM&G by June 3, 2017. One person may bring multiple artists' work; however, artwork cannot be sent via UPS, FedEx, or the Post Office. The Show will hang from June 8 through July 27, 2017. All accepted work must hang for the duration of the show. MMM&G will retain a 30% commission on artwork sold during the show. Limited Edition prints of accepted work (no more than 5 prints each, wrapped and on a hard surface) can be delivered on or before the day of the reception to be sold during the show. All unsold artwork must be picked up by August 5, 2017.

WORK NOT PICKED UP

Unless prior arrangements have been made, artwork not picked up on the specified dates shall be liable for a removal fee of fifty (50) dollars and a storage fee of two (2) dollars per day. MMM&G shall incur no liability for damage to items placed in storage. If you want someone else to pick up your work, he/she may do so with your permission. The name of the person picking up artwork will be recorded. ID must be shown.

LIABILITY

Although every care will be taken, liability cannot be assumed for loss or damage of submitted works. Artists wishing protection should insure their works independently. Most homeowners insurance policies cover personal property located off-site.

PRIZES

The Juror will determine first, second, and third place. At his discretion, the Juror may award Honorable Mention Certificates. A committee of the President and Board Members of the MacCallum More Museum and Gardens will determine the recipient of the MacCallum More Garden Award and, at their discretion may award an Honorable Mention Certificate. Winners will be announced, and cash prizes awarded, at an Awards Reception on June 11, 2017 from 3-5 pm. The awards will be announced at 3:30 p.m.

TIMELINE:

- Deadline for email and CD entries – May 13, 2017
- Deadline for entries dropped off in person - May 13 and May 20 from 10 a.m. to 4 p.m.
- Entries delivered to MMM&G, but not selected for the Show must be picked up May 24 through May 27, 2017.
- Deadline to deliver artwork selected for the Show – June 3, 2017 at 4 p.m.
- Show will hang from June 8 through July 27, 2017
- Reception will be June 11 from 3-5 p.m. Winners will be announced and cash prizes awarded at 3:30 p.m.
- Unsold artwork must be picked up by August 5, 2017 at 4 p.m.
